<a href="#">HB76, HD1</a>	RELATING TO TRAFFIC VIOLATIONS. Establishes a \$150 fine for traffic-control signal violations. Appropriates funds. (HB76 HD1)	TRN, JUD, FIN
<a href="#">HB1226</a>	RELATING TO GENETICALLY MODIFIED PLANT ORGANISMS. Preempts certain state administrative regulatory actions and county regulatory actions relating to genetically modified plant organisms. Excepts from the preemption any county ordinance that took effect before 01/01/09 and made unlawful certain actions relating to particular species of genetically modified plant organisms. Excepts also from the preemption any state administrative regulatory action or county regulatory action that bans, restricts, or otherwise regulates the growing of genetically modified taro.	AGR
<a href="#">HB1242</a>	RELATING TO TAXATION. Short form bill relating to taxation.	EBM, FIN
<a href="#">HB1359</a>	RELATING TO CONSUMER PROTECTION. Prohibits the Office of Consumer Protection from making consumer complaints publicly available in cases where the complaint was resolved in favor of the business against which the complaint was filed.	JUD
