^{**} Please note: Two versions of HB 984, SD2 were inadvertently filed -- the first was the bill that was filed with Standing Committee Report No. 1314 on April 9, 2009 recommending that HB 984, SD2 pass Third Reading. The second is the draft attached to Floor Amendment No. 7. Floor Amendment No 7 was adopted by the Senate on April 14, 2009, and the 48 hours constitutionally required notice of the final form of the second HB 984, SD2 has been satisfied. It is this version of the measure that the Senate will be voting on today.
