Nakagawa, RDH, to the Board of Dental Examiners ("Board"). The Department supports the confirmation of Ms. Nakagawa's reappointment to the Board.

Ms. Nakagawa is being reappointed to the Board as a dental hygienist member. She has been licensed since August 9, 1982, and her license is current, active, and in good standing.

Ms. Nakagawa is an extremely valuable member as she attends most of the Board meetings and actively participates during the meeting discussions. She always

prepares for the discussions on agenda items and shares valuable insights based on her many years of experience as a licensed dental hygienist. More importantly, Ms. Nakagawa is able to assess an issue, research the issue, and make meaningful recommendations.

Furthermore, as the current chair and as a member of the Board's Rules/Legislative Committee, Ms. Nakagawa has devoted countless hours researching and deliberating on possible amendments to the Board's administrative rules. My name is Cheryl Nakagawa. Thank you very much for the opportunity to submit this statement to extend my service to the Board of Dental Examiners for a second term. I truly enjoy working with my fellow board members who have a mutual respect for each other and are able to leave their other "hats" at the door when we sit at the board's table.

I hope to be able to continue to uphold the board's fiduciary duty to maintain public health and safety to 1) oversee the examinations, 2) issue licenses to qualified individuals, 4) conduct disciplinary hearings in the revoke or suspend licenses, 3) establish standards of practice and conduct, and to 5) promulgate these rules to enable the board to perform its duties and to uphold the laws that govern the practice of dentistry and dental hygiene.

It is my intention, as the new chairperson of the Legislative & Rules Committee, to expedite updates to the Hawaii Administrative Rules more efficiently.

The committee has begun a fast-forward tract, following parameters that will facilitate updating the rules: 1) The rationale will be based on the board's mission to protect the oral health and welfare and safety of our public dental consumer, as opposed to personal conveniences, constituent interests and financial gain; 2) Interpret and apply the regulations uniformly keeping in mind the rules of practice and procedure of the Department of Commerce and Consumer Affairs (DCCA) and the Regulated Industries Complaints Office (RICO), as our board relates to the other boards and commissions, the guidance of the board's executive officer, and the attorney general's office; 3) Rules created shall be reasonable rules, reflecting current practice trends and societal functions; current technology and anticipating future technology, and 4) All decisions shall adhere to data-driven assessments, with the use of current evidence-based research, definitions and terminology.

The committee is to utilize its vast resources available which includes scientific and research papers, executive summaries, standards, guidelines and position papers from various professional, state and federal organizations. We will also actively engage all stakeholders as advisors to the board which includes the expertise of our board members, professional organizations, state, federal and educational system resources.

Given such amazing opportunities such as to preside over various Parent Teacher Association boards at the local schools and state levels, to be the current secretary of the School Community Council, to participate as an American Dental Association Commission on Dental Accreditation team member and to facilitate various community projects over the years, has hopefully qualified me the to facilitate meetings effectively, as well as respectfully, for the board's most important work.
