During the past year, I have given presentations to business organizations to make them aware of who we are and what we do and will continue to so if I am selected for another term.

5. Name three qualities that best describe you and that would make you stand out. How would these qualities benefit the Small Business Regulatory Review Board?

I understand what it takes to run a small business. I have some understanding on how government works. And I always try to do the right thing. I think that these qualities would make me a productive member of the Small Business Review Board.

6. Name one previous experience that would make you stand out. How would this benefit the Small Business Regulatory Review Board?

I was awarded Kauai's first Small Business Administration's "Businessman of the Year". Although it was awarded a few years ago, it might give me some creditability to my knowledge of business.

I sell food to both of the Departments but it is strictly on a bid basis. There also may be an appearance of conflict of interest if we deal with the Public Utilities Commission. I am on the Board of Directors of Kauai Island Utility Cooperative which is regulated by the PUC. In any case, I will declare my possible conflict to my fellow board members for their guidance or I will recluse myself from the issue.
