# TESTIMONY OF SAM AIONA

# Gubernatorial Nominee Hawaii Public Housing Authority Before the SENATE COMMITTEE ON EDUCATION AND HOUSING Friday, March 13, 2009, 2:00 p.m. Room 225, State Capitol

Good afternoon Chair Sakamoto and members of the committee. My name is Sam Aiona and I am here today to ask for your support as I seek confirmation to the Board of Directors for the Hawaii Public Housing Authority. I have served as an interim member of the Board for the last nine months and would like to continue my service for the term which expires in 2011.

I am currently the Executive Director of the State of Hawaii Office of Community Services (OCS) and have served in this capacity since 2003. OCS serves the low income, immigrant and refugee populations in our community and we work with many non profit organizations throughout the state.

Since joining the Board of Directors I have learned a lot about the public housing system. But more importantly I learned about the residents of public housing, their concerns and their suggestions. I've also learned that those of us in government and those of us that sit on such boards have a fiduciary responsibility to the organization but we also have a responsibility to the people we serve to make sure they have the resources to succeed in life.

I was given a set of questions to answer and am happy to share with you my thoughts:

- a. Why do you wish to be a member of the Hawaii Public Housing Authority?
  - I would like to continue to be a member of the Hawaii Public Housing Authority Board of Directors because I feel I have the necessary experience and skills to make decisions that will result in a better quality of life for the residents.
- b. What do you perceive are the role and responsibilities of a member of the Hawaii Public Housing Authority?

First and foremost the role and responsibility of a board member is to make sure that the Authority is running smoothly. This means the staff has the resources, motivation and direction necessary to do a good job. This will require adequate funding, ample infrastructure, sound policy and the passion to help others. If the organization is run properly and things are in order, the residents can only benefit.

c. Given your understanding of the role and responsibilities of a member of the Hawaii Public Housing Authority why do you believe that you are qualified for the position? Please include a brief statement of your skills, expertise, or knowledge that would aid in your decision-making ability as a member of this Council.

Although infrastructure is a function of funding, and funding is the province of the Legislature, I believe I am qualified with regards to providing sound policy and the passion and commitment necessary. As I indicate below, I believe one my best qualities align perfectly with providing sound policy. Interacting in many capacities with the State, non-profits and the community over the years has given me the ability and experience to make balanced, fair, and responsible decisions.

Every decision I make as a board member comes with the interest of the residents and of the State in mind. As the Executive Director of the Office of Community Services I work with many non profits who directly serve low income residents of our community. Working with these non profits, speaking to clients, and engaging directly with the community I believe I have developed a good grasp of the needs and expectations of this community. Working in state government, I have the knowledge necessary to make decisions for the Authority in relation to the "State system". A balance can be achieved and my decisions are based on balancing the capacity and obligations of State government with the needs of the residents.

d. Name three qualities that best describe you and that would make you stand out. How would these qualities benefit the Hawaii Public Housing Authority?

Three qualities I like to think I bring to the board are passion to help people, knowledge of state government, and willingness to serve.

e. Can you foresee any possible conflicts of interests that could arise during your service on the Hawaii Public Housing Authority? How would you overcome any possible conflicts of interest?

Not currently. However, if one should arise I would bring it to the Board's attention, state my position on the matter and then possibly recuse myself if a material conflict existed.

f. What are three ways that the Hawaii Public Housing Authority should/must help meet the housing needs in Hawaii?

Three ways to meet the housing needs are creating properties with mixed used development, increase funding for capital improvements by streamlining process, and providing inventory proportional to the public's need.

g. What goals should the Hawaii Public Housing Authority set and how would you propose to measure them?

Our goals should be to make sure all public housing units are safe, secure and comfortable. Measuring safety means reducing the number of incidents on our properties caused by unsafe facilities. We can also measure safety by our maintenance routines and how recent our safety certifications were performed. The most important measure of security and comfort is the resident's perception of how comfortable and secure the facilities are. By removing housing as a barrier and challenge to the resident's success, we hope to alleviate this stressor and allow them to focus on other challenges. With help from service providers and other State agencies, we hope to introduce programs that will curb domestic violence, drug and alcohol use, and promote community, thereby all contributing to the stability, security, and comfort of the residents.

# Comments on bills submitted to the 2009 Hawaii State Legislature Sam Aiona - March 13, 2009

# SB1160 SD1-Asses units in public housing for common area expenses

Residents of public housing are obviously low income and assessing fees will not help their economic condition. However, all of us must take responsibility for our actions and if their action comes with financial implications they must bear the burden of correcting the action through compensation.

### SB734- Special Master to resolve Health/Safety violations

Although this bill has not survived, the Board of HPHA welcomes outside support and advice. We are not all experts in every aspect of housing challenges and regularly come across situations that require we solicit commentary. I appreciate the thought behind the bill, and I believe that this situation can be adroitly resolved through presentations to the Board by qualified experts in each field. I would appreciate the Legislature's help in facilitating these presentations.

### SB753-Security at Public Housing Facilities

This bill has also not survived the First Decking Deadline, but that does not diminish the importance or immediacy of security issues at these facilities. I believe security for the residents is one of the most important issues at Public Housing facilities. However hiring armed guards may not be the only solution. Community building, coupled with a drug and alcohol-free environment as well as partnership with social service agencies I feel can provide the residents the mutual respect they need to get along in tight living quarters.

### **SB663-Familial Status Definition**

I support the efforts to standardize documentation related to legal guardianship of a child. I also understand this bill is not meant to undermine the practices established as custom here in Hawai`i. However, the literacy of the people involved must be established. Having your name on a piece of paper does not always establish intent of the parents, it merely legally protects those that seek to break up that relationship. The burden of proof should be on the State if the child is not being abused or otherwise mistreated.

## **SB 1221-Criminal Trespass on Public Housing**

I support this bill, it adds teeth to officials designated by the HPHA to protect the safety and welfare of the residents. I would suggest you may also want to add conflict resolution training for these designated officials so they can recognize signs of escalation.

# **SB535-Prohibition on Alcohol Consumption**

This bill seems like a housekeeping measure that closes the loophole for those carrying alcohol but not actively drinking it. It is measures like these that will, as a whole, provide the security and well-being of the residents.

### **SB439-HPHA/Private partnerships**

I support the intent of this bill insofar as the State cannot afford to continually provide all the resources necessary to accomplish the Public good. Public/Private partnerships are an excellent tool to encourage the private sector and others willing to volunteer to help agencies like HPHA achieve their goals.

### **SB445-HPHA** procurement exemptions

This measure, like SB439, provides a mechanism to expedite the repair and maintenance of several key HPHA properties in order to meet certain standards. Although it is a good idea for an agency that was caught off guard, perhaps from an act of god or other unforeseen event, the HPHA needs to tighten up its administrative processes. Otherwise, we would just be loosening oversight on an agency that is not performing as the Board feels it should be with their current resources.

# **SB910- Homeless Branch move to BESSD**

The Homeless Programs within HPHA are much different than public housing because the homeless programs are just that – programs. The public housing side should develop more programs like the homeless section. Because the homeless programs are about self sufficiency they should be moved to BESSD so they can take advantage of the resources available within BESSD and continue to focus on programs to help residents.

### **SB1294-Fund Appropriation for Compliance Projects**

This bill has not survived. This measure is a straight appropriation bill, as such I will leave the decision up to the wisdom of the Legislature. I do support additional funding to bring the facilities up to code, however these are tough times and there are many worthy agencies that could use additional funding.

### SB455-Smoking at Public Housing Projects

I support the intent of this measure. As State funded projects, Public Housing units should be subject to the same regulations as all State facilities. However, we must remember these are people's homes, and as such we should allow them certain freedoms they would enjoy in market housing. Like many other issues in Public Housing, we must strive to strike a balance between the freedom afforded a homeowner, and the inconveniences a person causes their neighbor in tight living quarters.

# **SB757-Shelter in Place Pilot Program**

I am in favor of measures like this, though this one has not survived. As officials of the State we must be fair and even-handed. In such a program as this, there will likely be a population that we cannot serve due to fiscal constraints. Therefore, we must develop strict criteria as to being "in danger of homelessness." Ultimately, we may raise the ire of the public who ends up just above our criteria line that does not qualify.
