Aloha Chair Chun Oakland, Vice Chair Ihara and members of the committee. Thank you for the opportunity to provide you with background information on myself in your consideration of my confirmation to the Early Learning Council.

I am the oldest of six children from the island of Kaua'i where I graduated from Waimea High School. I moved to Honolulu after a year at Kaua'i Community College and received my BA, MA and Ph.D. from the University of Hawai'i at Mānoa. My Ph.D. is in Political Science and my area of concentration for my dissertation was Indigenous Education. I am a wife, mother of 4 and have spent my working years in a variety of positions that have prepared me to contribute to the Early Learning Council. I taught in the DOE in the Hawaiian Immersion program and had the opportunity to teach K, 1, 2, 5, 6, 7th and 8th grades while there. I also owned and operated 2 businesses American Bulldogs of Hawaii in Hau'ula and The Pa Lehua Project on the Big Most recently I was the Preschool Director and then Community Relations and Development Director at Keiki O Ka 'Āina and now for a little over a year I have been the CEO at INPEACE a Native Hawaiian non-profit with direct services in early childhood education and workforce development. At INPEACE we offer programs on Hawai'i island, Maui, Moloka'i, O'ahu and Kaua'i with a year round staff of 65 and an additional 80 staff members during the summer months. The key experiences I feel will help me in this appointment given the opportunity are those of a mother with 4 children who have collectively experienced every type of early childhood program available in Hawai'i from Parents as Teachers and HIPPY homevisiting programs, to private preschools including Seagull, KCAA, Kamehameha, and Pūnana Leo, to Keiki O Ka 'Āina's Family Child Interaction Learning program and family child care.
