#### Response to Questions for BOR Nominees Chuck Yim Gee, Candidate

1. What motivated you to apply to be a member of the BOR and what skill sets and experiences do you bring to the table that will help move the University forward?

My motivation stems from a personal interest in the continuing progress of the University of Hawaii and my belief about the vital role that the university plays in preparing students for future leadership responsibilities in our state and the AP region. Economic and social progress requires an educated citizenry that understands change, competitiveness, and the urgency of response to problems that are both local and global. My 32 years of service in building a TIM School that could respond to local needs as well as international interests was done to promote the visitor industry's, the UH and the state's outreach in the AP region. Among other qualifications, I bring an international perspective to the table.

# 2. What specific short and long term goals do you have for improving the University?

The short term goal is to address the immediate financial exigencies facing the university and see that resources are allocated in an even-handed manner between the 4-year colleges and the community colleges. However, "even-handedness" does not mean equity of distribution. Programs recognized as "priority" because they serve vital community interests or enhance the university's education and research mission must be strongly supported, even as marginal programs are allowed to phase out.

Having achieved its centennial in 2007, the University has come a long ways from its early beginnings as a land-grant college of agriculture and mechanical arts under the Morrill Act. Its future and long term goals are linked with its past as a state-wide institution serving a wide variety of education and research needs, and its growing importance nationally and internationally. My own long term goals do not differ significantly from the university's nor its supporters, which are: (a) to improve the university's productivity in those areas that make the UH unique among its peers, i.e., strengthening its status as a Land-Grant, Sea-Grant, and Space-Grant university, (b) to continue supporting programs that are vital to the state's economic/social interest in astronomy, oceanography, technology, science, health and medicine, diversified agriculture, tourism, <u>and</u> programs deemed vital for sound basic education, (c) to promote public-private partnerships between the UH and the business community and through international alliances, (d) to seek increased external support by strengthen alumni and donor ties to the UH, (d) to improve the accountability of the university for use of public resources through greater transparency in report-outs.

# 3. As a regent, what will be your top 3 priorities for the University?

My three priorities can be summarized in a few words: Improved productivity throughout the system, prioritization of programs for funding support, and public accountability. Especially at a time of budgetary constraints throughout the state, the university must also make wise use of resources with tough decisions about "selective areas of excellence." With a new president to be chosen for the UH, this should be seen as an opportune time to reorganize for streamlining academic units and eliminating things that do not contribute to the University's vision or mission, perhaps a time to return to basic values encompassed in its mission and to revisit its vision for the future.

4. In the coming months, the BOR will be called upon to select a new president. What will be qualifications that you consider most important? What do you feel are the most important duties of the president, and what kind of relationship should exist between the board and the president?

A search committee is well underway with a long list of MQs and DQs for the position based on internal campuses and external community meetings on each island. Be that as it may, I have had the experience of serving under five UH presidents and two interim ones, beginning with Tom Hamilton, Harlan Cleveland, Fujio Matsuda, Al Simone, and Ken Mortimer, not to mention as many chancellors. In my experience, the presidents that did the best job of administration were those who had an outstanding academic background with wide respect in his/her field, had strong people skills and tolerance for differences of opinion, ability to communicate and to lead, a sense of vision, a collegial style of management and pragmatism in dealing with exceptional problems. The best presidents were also viewed as an effective spokesperson for the UH and as a community leader. The most important duties of the president are not so much the day-to-day ones of system management that can be delegated, but more in developing and promoting ideas which define the greatness of a university and selling the message to all of its stakeholders within the system and to its external constituencies. However, ideas are only as good as their delivery, requiring the president to know how to optimize the use of resources-faculty and facilities, student bodies, support personnel, public and private funds-in order to do more with less. This requires ability to persuade and to secure cooperation that is often circumvented by on and off campus politics. One important role for the next president will be external fund-raising to supplement state allocations and specials funds from existing programs.

## 5. We are currently faced with an unprecedented budget crisis. What ideas do you have for generating revenue for the University and how we approach any cuts that have to be made within the budget?

Budget cuts are not new to me. With rare exceptions during the Cleveland and Simone years, I faced cuts constantly as a dean. Revenue generation can come from a variety of sources: state allocations, external research gifts and grants (which now exceeds \$300 million annually), special funds from earned income, and not least, tuition and fees. From a societal development standpoint, tuition increases should not be the main answer to financial woes. However, different professional programs have high demand and high costs of operation; further study should be made to see whether or not sharper tuition differentials should be supported for these programs. Community college tuition levels are also low, and some readjustments might be considered, keeping in mind the question of affordability and the mission of the community college system. The importance of external fund-raising must be stressed, not only to secure additional resources, but as a sign of commitment from outside supporters towards the building of excellence in education, training, research and other aspects that define a first rate university.

Internal budget reviews to prioritize programs by representational committees on each campus are possibly the most acceptable way to accomplish cuts. The process is not an easy one, but has been done in the past whereby committees are charged with the task of prioritizing programs deemed (a) essential to the university's basic mission, (b) programs needed to support the core educational foundation, (c) programs supporting the state's economic development, (d) programs that generate their own support in research and training, and (e) enhancements programs defined as "nice to have, but not vital." Beyond programs, policies can help determine areas for reduction. The hiring of administrative personnel, for instance, should have lower priority than academic hiring. Promotion from within might be favored over bringing in outside recruits, usually at much higher salaries and perks. Cuts should not be micro-managed, but left to each department, school, college, and campus to determine at levels where cuts can be most effectively made, so long as a degree of flexibility is also permitted.

6. How do you view the role of the system as it relates to the 10 campuses? Do you feel that the relationship as it exists now should be changed? How will you ensure equity of resources across all campuses?

My feelings on the subject have wavered over the years. On the one hand, I see a senior university as having a very different role in higher education and research than community colleges whose primary responsibilities lies in training and readiness for employment upon the completion of training. On the other hand, I have observed the university becoming better integrated as a functioning system. Articulation between the CCs and the three senior universities has facilitated transfer among the various campuses, and permits a degree of flexibility in programs cooperation. Under a single system, there is less waste and duplication. Where there are overlaps, there is also consultation. Generally, there seems to be greater appreciation for the advantages of a systems approach that outweighs the battle for individual campus sovereignty, but no final agreement on the issue.

Equity of resources is not necessarily giving each campus the funds it requests. Rather, equity is ensuring that each campus will be given <u>equal consideration</u> with respect to its priority requests for programs, personnel and facilities. BOR approval must be based on justification derived through a rigorous internal deliberation, administrative recommendations, and recognized needs.

# 7. What kind of relationship do you feel should exist between the University and the Legislature? More specifically, how would you view the relationship between the BOR and the Legislature?

The University is a public institution which derives its main support from public taxes. As the Legislature represents the general public, the University must be accountable to the Legislature for the funding it receives. The relationship is ultimately one of information exchange and cooperation in working towards common goals for the public good through higher education. There is, of course, a fine line separating what are institutional priorities arrived through an arduous process, the mandates of accrediting bodies, and vested interests of outside parties. An established protocol for ensuring open communications between the University, its BOR, and the State Legislature is important for promoting timely exchanges and accountability. Regents have a fiduciary responsibility to ensure that university assets are being used wisely to accomplish educational goals and mission. The Legislature has a responsibility in seeing that the BOR has discharged its responsibility of effective oversight in the governance of a complex University system. The defining relationship between BOR and Legislature must be one built on mutual trust, transparency of process and willingness to work cooperatively to resolve critical problems.
