Aloha e Honorable Tokuda,

It is with great enthusiasm that I endorse the nomination of Eric K. Martinson to the University of Hawaii Board of Regents [GM 310 AND GM 468]. I have known Eric for over twenty years as a professional colleague and personal friend and feel well-qualified to comment on his qualities and attributes that will serve him well as a Regent of the University of Hawai'i.

Eric was a financial analyst at the Bishop Estate in 1988 when I joined its beneficiary, The Kamehameha Schools, as President. At that time, Eric worked closely with former Trustee Matsy Takabuki, earning organization-wide respect and appreciation for his probing and analytic intellect and eventually became Director of the Estate's Financial Assets Division responsible for its global financial portfolio. In that capacity, Eric retained responsibility for Division operations; however, it was his ability to think and vision strategically that proved vital to the success of our portfolio and in my mind, is his greatest strength. During this time, Eric interacted and engaged with the finest minds and experts in national and international finance and helped transform the Bishop Estate into a major player in the financial world. Eric left the Bishop Estate in solid financial condition after laying a foundation upon which further growth could and did occur. In his humble fashion, Eric will deflect all praise and recognition to his mentor, Matsy; however, Matsy himself would say otherwise and point to Eric's role in the Bishop Estate's financial success as key. Clearly, Eric brings to the Board of Regents two important professional attributes -relevant experience and rigorous intellect, both of which will contribute greatly to the work of the Board.

In describing Eric Martinson at the personal level, the first descriptor that comes to mind is integrity. His word is good, truth is never compromised, decisions are evenhanded not judgmental and he strives to do right without being righteous. Eric has many attractive attributes; however, integrity is what shines brightly in my eyes and is the single-most important quality in which my respect and esteem for him is rooted. But integrity also requires courage because oftentimes doing the right thing means standing by your self. Eric has demonstrated this quality as well. At a decisive point in his career, Eric was faced with compromising his integrity on the one hand by "going along to get along" and keeping his integrity on the other by stepping away from an institution that he loved dearly and a career that was gaining momentum. He stepped away. That took courage and sacrifice, which the Board of Regents needs as it deals with the different interests, needs and views of the University of Hawai'i's many stakeholders.

Eric is an effective communicator who is at the same time candid and



collaborative. For some, candor and collaboration might appear oppositional. However, how the message is delivered will determine whether the message is delivered and Eric is able to engage in conversations and deliberations that are forthright and open without being confrontational because he focuses on issues not personalities and because he listens with respect and with an open mind. He is able to honor other views without agreeing to those views and as a result is able to sustain discussions and dialogue to reach reasonable compromise. The Board of Regents is all about communications and effective communicators are vital to its work. Eric's accomplished communications skills will add greatly to the work of the Board.

Having graduated from Kamehameha Schools, Eric has firm roots in his Hawaiian culture. He is an accomplished dancer and embraces the traditions of his Polynesian ancestors. However, Eric is also very much entrenched in his Japanese culture, providing important leadership to the Japanese Cultural Center and introducing his children to those traditions as well. Of course his professional success is testimony to his ease and skill in operating within Western culture. What all of this points to is Eric's comfort with diversity, a uniquely distinguishing feature of the University of Hawai'i. He is a child of diversity, having experienced all that comes with being multi-cultural, including the stereotyping associated with different ethnicities. These experiences have helped to make him the person that he is today -- one who appreciates the richness that diversity brings to our lives and accepting of those who look, think and act differently than he does. The Board of Regents itself is a diverse body and Eric will add to this important characteristic.

In summary, Eric Martinson is extremely well-qualified to serve as Regent of the University of Hawai'i -- he brings credible competence, upstanding character and engaging chemistry to the work of the Board and will serve with distinction. At Kamehameha, we strive to inspire and instill in our students those values and lessons that will help them to become "good and industrious men and women" in accordance with the Will of our benefactress, Bernice Pauahi Bishop. Eric learned those lessons and values well as evidenced by how he lives his life each day.

Mahalo for this opportunity to attest my support for Eric K. Martinson's nomination to the Board of Regents of the University of Hawai'i. Hawai'i's higher education system will be well served by his appointment.

My name is Andrew Hashimoto, and I am the Dean and Director of the College of Tropical Agriculture and Human Resources (CTAHR) of the University of Hawaii at Manoa. I am pleased to contribute personal testimony to the decision-making process on GM 468, the consideration and confirmation of Mr. Eric K. Martinson as a member of the Board of Regents of the University of Hawaii, and extends Mr. Martinson's term specified in GM 310 from expiring on 6/30/09 to 6/30/2014. I am in strong support for Eric Martinson's appointment to the Board of Regents.

I served with Eric on the Kamehameha Schools/Bishop Estate Board of Advisors. He has been a member of the boards of the Sierra Club, Sopogy, Inc., Royal Hawaiian Showroom LLC, BPA Technologies, Entrepreneurs Foundation of Hawaii, Hawaii Imin Shiryo Hozon Kai, to name a few.
