Madame Chair and Members of the Committee,

I am testifying as an elected student representative of over 3,000 Students of Honolulu Community College (HCC).

We are opposed to the confirmation of Grant Teichman as Student Regent of the University of Hawaii Board of Regents.

The purpose of placing a Student Regent on the Board of Regents is to ensure that concerns of the Students of the University of Hawaii are addressed at the highest level of University governance. Generally speaking, the record points to a less than sincere effort. How can Mr. Teichman effectively represent our viewpoints when:

- 1) He has denied student leaders at student caucus the opportunity to meet with him so that he could be made aware of student concerns and affairs.
- 2) He has attended only 1 out of 3 scheduled Board of Regent Meetings (an attendance rate of 33%)

Students, Faculty, and the People of our State deserve a 100 percent effort from all of our student leaders. Our community faces a number of hard challenges ahead, and we the Students of Honolulu Community College are prepared to do our part. We strongly feel that our regent should also reflect that level of communication and commitment.

We respectfully ask this committee to withhold the confirmation of Grant Teichman and ask that a refreshed list of candidates be summoned.
