The State Council on Developmental Disabilities (DD) **STRONGLY SUPPORTS GM 318** to confirm the nomination of Ben S. Dalauidao II, for a term to expire June 30, 2012.

The Council's Federal mandate (P.L.106-402) is clear in determining the composition of this body to ensure that all the players involved in the development, implementation, and use of DD supports are represented. The law specifically requires that 60 percent of the membership of the Council be comprised of individuals with DD, their parents, or family members. Additionally, the following agencies are required to be on the Council: Department of Health (DOH); the agencies that administer funds provided under the Rehabilitation Act of 1973; the Individuals with Disabilities Education Act, the Older Americans Act of 1965; Titles V and XIX of the Social Security Act; the Protection and Advocacy Agency; the Centers for Excellence in DD Education, Research, and Service; agencies and private non-profit organizations concerned with services to individuals with DD. The Governor's nominee meets all the Federal requirements for Council membership.

Mr. Dalauidao is an individual with a developmental disability who resides on the Big Island. He was first appointed to the Council in July 2008. He is an active member of the Council's Employment and Education Committee that is working to increase employment options and promote individualized school transitions to postsecondary options for individuals with DD. As a self-advocate, he represents individuals with DD from East Hawaii and is a very motivated member of the East Hawaii DD Committee.
