Chair Espero, members of the Senate Committee on Public Safety and Military Affairs, thank you for this opportunity to present background about myself in your consideration of my confirmation to the Wireless Enhanced 911 Board.

I was born and raised in Detroit, Michigan. I attended and graduated from Southeastern High School in Detroit, Michigan, Macomb Community College in Warren, Michigan, receiving an Associates of Applied Science in Electronic Engineering Technology, Sienna Heights University, Adrian, Michigan, receiving a Bachelor of Applied Science in Electronic Engineering Technology.

I have worked in the Telecommunications field for 22 years beginning my career at Michigan Bell Telephone Company as a Switching Equipment Technician. In 1996 I transferred to BellSouth Mobility as a Network Engineer responsible for Transport and Traffic Engineering in Bakersfield, California and Birmingham, Alabama. In 2000 I transferred to Atlanta, Georgia with Cingular Wireless (now AT&T Mobility) as a Principal Member of Technical Staff developing and deploying new products and services for Cingular Wireless in the CTO organization. In 2005 I transferred to Mililani, Hawaii as the Network Sales Support Manager.
