GOVERNOR'S MESSAGE 385 - SUBMITTING FOR CONSIDERATION TO THE ISLAND BURIAL COUNCIL, ISLAND OF HAWAII, GUBERNATORIAL NOMINEE, JAMES G. LEE JR.

It is with pleasure that the Department of Land and Natural Resources (Department) recommends Senate confirmation of the appointment of James G. Lee Jr. to the Hawaii Island Burial Council.

The Island Burial Councils were established under Section 6E-43.5, Hawaii Revised Statutes, to determine the preservation in place or relocation of previously identified native Hawaiian burial sites and to determine Hawaiian cultural and lineal descendancy claims for specific burials. State law requires that Island Burial Councils be established for Hawaii, Maui/Lanai, Molokai, Oahu and Kauai/Niihau islands, comprised of representatives from specific geographic regions and representatives of developer/large property owners.

James G. Lee Jr. was nominated to serve as a Landowner/Developer representative on the Hawaii Island Burial Council. If confirmed, James G. Lee Jr. will serve until June 30, 2013.

James G. Lee Jr. is currently employed with the W. Shipman Company as the Director of Development. He brings a diversity of professional experiences to the council's deliberations. The Department notes that James G. Lee Jr. currently serves as a valued member of the Hawaii Island Burial Council.
