GOVERNOR'S MESSAGE 386 - SUBMITTING FOR CONSIDERATION TO THE ISLAND BURIAL COUNCIL, ISLAND OF OAHU, GUBERNATORIAL NOMINEE, AARON D. MAHI

It is with pleasure that the Department of Land and Natural Resources (Department) recommends Senate confirmation of the appointment of Aaron D. Mahi to the Oahu Island Burial Council.

The Island Burial Councils were established under Section 6E-43.5, Hawaii Revised Statutes, to determine the preservation in place or relocation of previously identified native Hawaiian burial sites and to determine Hawaiian cultural and lineal descendancy claims for specific burials. State law requires that Island Burial Councils be established for Hawaii, Maui/Lanai, Molokai, Oahu and Kauai/Niihau islands, comprised of representatives from specific geographic regions and representatives of developer/large property owners.

Aaron D. Mahi was nominated to serve as the Koolau Poko District representative on the Oahu Island Burial Council. If confirmed, Aaron D. Mahi will serve until June 30, 2013.

Aaron D. Mahi brings a deep understanding of the Hawaiian traditions and culture to his council duties. He is a highly respected Hawaiian as well as an internationally acclaimed musician. The Department notes that Aaron D. Mahi currently serves as a valued member of the Oahu Island Burial Council.

The Department greatly appreciates your consideration of Aaron D. Mahi and strongly recommends his confirmation to the Oahu Island Burial Council.
