It is with pleasure that the Department of Land and Natural Resources (Department) recommends Senate confirmation of the appointment of Ivan I. Nitta to the Köke'e State Park Advisory Council.

Mr. Nitta was born and raised in Kekaha and spent a lot of time hunting in Kōke'e and Waimea Canyon, fishing at Pu'u Lua Reservoir, and hiking the trails throughout the park. From 1968 to 1978, he was a power plant operator and involved in facilities maintenance for the NASA Tracking Station, located in Kōke'e State Park. From 1967 to 1973, as a guardsman with the Air National Guard, he also operated the back up power plant at Kōke'e Air Force Station.

For more than sixty years, Mr. Nitta's family has had a recreation residence in Pu'u ka Pele and he recalls the many changes he has seen within the park community as well as the impacts to the natural resources. Environmentally sensitive, he is committed to preservation of the resources and the local lifestyle that he so cherishes.

With these qualities and his personal knowledge of the lands within Kōke'e and Waimea Canyon State Parks, the Department is confident that Mr. Nitta will make significant contributions as a member of the advisory council that will serve the best interests of the people of Hawai'i. The Department supports his appointment for a one-year term as well as his reappointment for another three-year term and request that his nomination be confirmed.
