Thank you for the opportunity to provide testimony in <u>support</u> of the confirmation of Clarissa Hosino to the Board of Directors of the Hawaii Public Housing Authority (HPHA). As Executive Director of HPHA I have worked with Ms. Hosino on matters before the HPHA Board and am aware of her contributions and qualifications.

It is important to have the voice of our public housing residents heard not only at Board meetings, but also on the Board itself. HRS 356D-3, which established the HPHA Board of Directors, requires that one member be a beneficiary of HPHA services.

Ms. Hosino serves as the Resident Member and is a forceful voice for residents. She attends resident community meetings regularly and brings to the Board many of the concerns that might not otherwise be raised at that level. As a member of the Board, Ms. Hosino is able to communicate the Board's policies and intentions to residents at those meetings with an authority beyond that of the HPHA staff.

Active resident associations are important to the effective operation of the public housing system and the goals of Hawaii Public Housing Authority. I am writing this testimony on behalf of Clarissa Hosino, who is currently on the HPHA Board of Directors as the Resident Representative.

As coordinator for the Resident Advisory Board, I have come into contact with Clarissa, who makes it a point to attend every RAB meeting that we have because she feels that it's very important to have input into the policies that are outlined in the Public Housing Agency's 5 year and annual plan. She takes the time to consult with the residents from various housing projects (not only her own) as to what the resident's view are regarding issues being discussed. The viewpoints and opinions that she brings to the table, are truly reflective of the residents that she represents.

Clarissa and I have been working together in establishing resident associations at every public housing property and providing assistance to those associations that are already established. Clarissa realizes that it is important that each property have an association to coordinate activities to bring the residents together but more importantly to be the "eyes" "ears" and "voice" of the residents.
