#### Dear Senator Hee:

This letter is in response to my nomination by Governor Linda Lingle to the Board of Directors of the Aloha Tower Development Corporation, and your request for information to be submitted to your office. I will respond to the items reflected in your letter in chronological order as it appears in the letter:

  - (a) Why do you wish to be a member of the Board of Director of the Aloha Tower Development Corporation?
    - I believe in public service and throughout my professional career I have been involved in various community organizations, committees, boards and organizations. I always felt that it was my civic duty to participate in, and support our community utilizing the knowledge and experience that I have gained in the banking and lending industry. However after I left the banking industry to pursue my self-employed business, my involvement in the community was significantly reduced. In 2006, the opportunity to serve on the ATDC Board of Directors allowed me to get involved in public service and utilize my knowledge and experience to help guide the Aloha Tower Development Corporation in meeting its mission and objectives.
  - (b) How do you perceive the role and responsibilities of a member of the Board of Directors of the Aloha Tower Development Corporation?
    - My role as a member of the Board of Director of the Aloha Tower Development Corporation is to continue to use my background and experience to complement the other Board members in our oversight and the development of the Aloha Tower and surrounding waterfront areas.

My responsibility is to continue to implement the ATDC's development objectives while acting in accordance with our mission statement. However

we must ensure that our actions are always in the best interest of the State of Hawaii. The decisions that are made by the Board of Directors reflect what we believe are the right decisions to make and are not the "easy way out." Unfortunately, at times these decisions could reflect badly upon ATDC.

(c) Given your understanding of the role and responsibilities of a member of the Board of Directors of the Aloha Tower Development Corporation, why do you believe that you are qualified for the position? Please include a brief statement of your skills, expertise, or knowledge that would aid in your decision-making ability as a member of the Board of Directors of the Aloha Tower Development Corporation.

During my 28 years in commercial real estate and business lending and the banking industry, I have acquired the knowledge, experience and expertise in commercial real estate and business financing utilizing an assortment of government-assisted loan programs and conventional financing. Besides soliciting and originating loans, I am able to underwrite and prepare financial analysis; complete comprehensive loan application packages; order and review MAI Appraisals/Environmental Reports/ALTA Surveys/Title Reports; deal with Private Sector/DLNR/DHHL leasehold properties; and have extensive processing and servicing background. These are the kinds of skills and experience that directly apply to the work at ATDC.

In addition I have been able to establish invaluable contacts with the USDA Rural Development, US Small Business Administration, USDA Farm Service Agency, Economic Development Administration, related state agencies, and conventional and alternative lending institutions in Hawaii and the Mainland. The geographic areas that I have arranged financing for includes the entire State of Hawaii, American Samoa, Guam, the Commonwealth of the Northern Marianas Islands; and I have worked on financing requests on the Mainland.

Several of the larger or community-based projects that I have been involved with include, but are not limited to, the following: Filipino Community Center, North Hawaii Community Hospital, Maui Economic Development Board, Island Pacific Academy, Waipahu Community Association (Waipahu Festival Marketplace), Hawaiian Waters Adventures Park, Cyanotech, Ballard Mortuary, Big Island Toyota, Hamakua Macadamia Nut Company, Hamakua Heritage Farms (Hamakua Mushrooms), Fat Law's Farm, Tony Hyundai, Old Lahaina Lu'au, Pacific Whale Foundation, Puna Certified Nursery, Tradewinds Hotel (American Samoa), Guam Industrial Services and Casamar Manufacturing (Guam).

(d) What do you hope to accomplish during your term of service?

During my initial 3-years of service on the Aloha Tower Development Corporation Board, I have had to deal with projects and litigation that were already ongoing and needed to be addressed and settled. Based on my The Honorable Clayton Hee March 19, 2009 Page 3

lending and business background, I volunteered my time on several subcommittees in the hope of helping to resolve these matters.

Over the next 4-years of service, I hope that all remaining issues and litigation will be resolved and that we continue to work hard to assist existing businesses to ensure their financial viability during these very difficult economic times. And, if the economy permits, we will move forward with new projects within the Aloha Tower area. Moreover, we have been given the additional task as the development arm of the Harbors Modernization Plan. I am confident that the ATDC Staff, Harbor's Modernization Group and the Aloha Tower Development Corporation Board will be able to implement the planned statewide harbor improvements in an expeditious manner. I believe that my lending background will be a positive influence to this task.

(e) Name three qualities that best describe you and that would make you stand out. How would these qualities benefit the Board of Directors of the Aloha Tower Development Corporation?

The three qualities that best describe me are dedication and hard work; objectivity; and patience and integrity. In my almost 3-years of serving on the Aloha Tower Development Corporation Board, I have made a serious effort to attend all Board Meetings and have missed only one meeting due to travel. I have served on a handful of sub-committees, attended meetings and have made an effort to keep up with all of the written materials that we are given pertaining to our Board responsibilities and duties.

Working with hundreds of businesses throughout the years, working with the various government loan programs, and serving as the current Board President of the non-profit Hawaii Alliance for Community Based Economic Development, I believe that I have learned to be objective in my views. And, you need to have a great deal of patience when you specialize in government assisted loan programs and the voluminous paperwork required. Last but not least, you cannot survive being a viable entity in Hawaii for the past 9-years and engage in my type of business if you do not have integrity with your clients, government agencies and lenders.

(f) Name one previous experience that would make you stand out. How would this benefit the Board of Directors of the Aloha Tower Development Corporation?

Receiving my kidney transplant in 2001 from my wife is the one experience that stands out in my life. It has kept me focused on how precious life is and my perspective on what is important in life. It has taught me the true meaning of unselfishness, motivated me to continue to serve my community, kept me grounded in my values, and broadened my ability to stay calm during adversity. My health and life could have been a lot worst than it is right now so I really make an effort to stay calm, be objective, try to find solutions and remember that there will always be another day.

If I was ever faced with a conflict of interest situation, I would notify the Chairperson of the Board and recuse myself from being involved in any Aloha Tower Development Corporation matter related to the possible conflict of interest.
