Chair Ige, members of the Senate Committee on Health, thank you for this opportunity to present a brief background about myself in your consideration of my confirmation to the Disability and Communication Access Board.

I was born and raised in Hawai'i. I attended the University of Hawai'i at Manoa, receiving a Bachelor of Science degree, majoring in Human Development. I attended the University of North Carolina at Chapel Hill for post-graduate work in Public Health Education and received my Masters of Public Health degree in Community Health Education at the University of Hawai' i's School of Public Health.

During the past 32 years of my professional career, I have served as a Public Health Educator in the State Department of Health and other non-profit agencies and since 2002 as a Planner for the Developmental Disabilities Division (DDD). I have had the pleasure to serve as the Professional Co-Chair of the West Honolulu Community Children's Council as our DDD representative since 2004. The Community Children's Council is under the State Department of Education whose focus is to address systems improvement in the delivery of services and support to special needs children and families statewide.

I also previously served on the State Department of Human Services, Vocational Rehabilitation & Services for the Blind's Imua Project as an Advisory Committee member from 2002-2003. This project focused on the successful transitioning for youth with disabilities at several high schools on Oahu and the Big Island.

Recently my Division's work on disaster preparation planning for our individuals with developmental and intellectual disabilities has given me the opportunity to work with the staff of the Disability and Communication Access Board (DCAB) in their statewide planning for disaster preparation for special needs individuals. I have been very impressed with their coordination and facilitation of all stakeholders to provide input into the planning process and to keep our group on task to implement the objectives that we have all agreed upon annually. I would be very honored to serve on this Board and contribute to the efforts of DCAB's strategic plan and advocacy of our disabled community's needs.

On a personal note, I have been blessed to have a sister with an intellectual disability from birth who is currently in her mid-40's. She resides with my elderly mother who is hard of hearing. My other sister and I provide supports, such as transportation, going with her to doctor visits, interpretation of correspondence, and to help her with her daily life activities. She has taught me a lot about how I treat her peers with an intellectual and physical

disabilities and to advocate for her and others in being respected and advocating for their needs. I also have a physical disability and have been a recipient of the services that DCAB provides through their administration of the American Disabilities Act laws.

A position on the Disability and Communication Access Board to serve as a family member of a person with a disability would provide me further opportunity to gather information and provide input from the community groups that I serve on, on the issues and services that DCAB provides to special needs individuals statewide. I offer my time, experience, and advocacy skills in assuring that the voices of those we help are heard in DCAB's plans.

It is with great pleasure that I submit this letter of recommendation for Ms. Lynn Murakami-Akatsuka in support of her nomination to serve as a family member on the Disability and Communication Access Board.

I have known Ms. Murakami-Akatsuka for over twenty years, both professionally and personally. Professionally, she has been a health educator and planner for the Department of Health. Most recently, from 2002, she has been the planner for the Case Management and Information Services Branch (CMISB) with the Developmental Disabilities Division; I was also her supervisor from 2002 until my retirement in 2007.

My name is Deborah Miyasaka-Gushiken and I am in **STRONG SUPPORT OF GM 501** to confirm the nomination of Lynn K. Murakami-Akatsuka to the Disability and Communication Access Board (DCAB) for a term to expire June 30, 2010.

DCAB as established pursuant to Chapter 348F, Hawaii Revised Statutes, is a seventeen voluntary member board whose members include at least nine people with disabilities, or parents or guardians of individuals with disabilities, and individuals knowledgeable in areas for which the board has rulemaking authority.

DCAB administers the statewide program on parking for persons with disabilities; advocates for people with disabilities on areas relating to access; establishes administrative rules for the design of buildings, facilities, and sites, and for communication access services for the deaf, hard of hearing and deaf-blind; serves as the designated state agency to coordinate the efforts of the State to comply with the requirements of the Americans with Disabilities Act (ADA) for access to services, employment, telecommunications, and facility and site design; reviews problems, needs and availability of services and resources for people with disabilities; provides technical assistance; and certifies interpreters for the deaf and hard of hearing for the State.

Ms. Murakami-Akatsuka has sister with an intellectual disability and is nominated to serve on the board as a family member of an individual with a disability for a one-year term.

Ms. Murakami-Akatsuka, herself, has a physical disability and has been a recipient of services from DCAB under the ADA.

Since 2002, I have had the pleasure of working with Ms. Murakami-Akatsuka in her capacity as a planner with the Department of Health Developmental Disabilities Division Case Management and Information Services (CMIS) Branch while I was employed by the CMIS Branch and in my current employment with the State Council on Developmental Disabilities.

Her work as a planner has contributed to improving the quality of life for individuals with developmental disabilities, and has involved analysis of and planning to address system level issues facing individuals with developmental and/or intellectual disabilities relating to the provision of services, supports, and resources. She also worked as public health educator for over twenty years. Her professional experience and training in these areas will contribute greatly in the review of problems, needs and availability of services and resources, and issues relating to access for people with disabilities that may arise before the board.
