Chair Ige, and members of the Senate of the Twenty-Fifth State Legislature. I would like to take this opportunity to present you with some background information on myself. I would also like to thank you for consideration of my confirmation to the State Council on Mental Health.

I first moved to Hawaii in the year 1967 with my parents and lived in a teacher's cottage in Kapaa. After schooling at McKinnley High, I moved to the mainland in 1973 and began working as a construction worker/truck driver. In the late-70's I was hired in a temporary position as a State Patrol Officer at the Parsons State Hospital in Kansas. I moved back to Hawaii in 1985-1986 before returning to the mainland. Most recently, I moved back home here to Hawaii in 1991 to attend college and obtain a degree as a Registered Nurse.

I have worked as a charge nurse at Kuakini Hospital in long term care. I went on to be a dialysis nurse, then a charge nurse at Kaiser Hospital in long term care. I cared for psychiatric patients from time to time in the long term care setting. I then accepted employment with the state and worked as a charge nurse at Hawaii State Hospital in Kaneohe for 4½ years. Eventually I transfered to the state licensing branch where I monitored care homes (with psychiatric residents) and special treatment facilities. After completing 10 years of state service, I began working at Kahi Mohala Hospital as a psychiatric charge nurse for 9 months, eventually returning to state service in January 2009 to my present position. I currently serve as a liason/nurse monitor between the Department of Human Services (DHS), Med-QUEST Division and APS Healthcare, the behavioral health contractor providing services for our Seriously Mentally III (SMI) members enrolled in DHS health plans.

I have enjoyed working with psychiatric clients and as a member of the State Council on Mental Health, I may be able to share some insight on mental health issues. I have witnessed changes occurring from as far back as 1978 up to recent times and have some experience in dealing with people having mental health issues.
