Chair Taniguchi, Members of the Senate Committee on Judiciary and Government Operations, thank you for this opportunity to present my background for your consideration of my confirmation to be a member of the Language Access Advisory Council (LAAC).

I am an Executive Vice President, and Head of International Banking for the Bank of Hawaii. My business and team members cover the international clients of the Bank, including foreign visitors, newly-settled immigrants and members of the Asian ethnic communities who may feel more comfortable to communicate in another language than English, or do business with people who understand their cultural needs. Bank of Hawaii's international division is the largest of its kind among the banks in Hawaii. We have five teams that focus on five of the major ethnic communities in Hawaii – Japanese, Korean, Cantonese, Mainland Chinese, and Filipino. We provide brochures and web sites in different languages and my team members are able to assist our clients in 10 different languages and dialects. Our mission is not only to leverage our language capabilities to develop business for the Bank of Hawaii, but also to help attract international visitors to the Islands.

I myself am a native of Vietnam, and have lived, studied, and worked in a number of countries including Vietnam, India, France, Russia, China and Hong Kong (besides Mainland US and Hawaii). I obtained both a B.S. and M.B.A. degrees from the University of Maryland. Before going into banking, I have worked for the US government in Washington DC as well as in Moscow and Beijing. I have over 23 years of experience in banking, first in Hong Kong and then in Hawaii since 2005. My exposure to the international market has allowed me to learn a number of languages and this has helped me in my current business. I am fluent in Vietnamese, French and English and am conversant in Mandarin Chinese.

I believe that I can contribute to the LAAC due to my close association with the various ethnic communities in Hawaii, as well as through my business that deals with companies catering to foreign visitors. My team and I are active members of various Japanese, Korean, Chinese, Vietnamese, and Philippine associations and chambers. My objective is to assist LAAC to expand the language facilitation in government agencies as well as among the private industry, in particular the Hawaii tourist industry.

Good morning, Members of the Committee on Judiciary and Government Operations:

Thank you for allowing me to testify today. I am Serafin "Jun" Colmenares the Executive Director with the Office of Language Access (OLA). The OLA strongly supports the confirmation of ANH BROW to the Language Access Advisory Council to represent a resident of the City and County of Honolulu who has an interest in language access.

Ms. Brow is a new Council member who is the Executive Vice President and Head of the International Banking Division at Bank of Hawaii. She is responsible for all banking activities for international clients of the bank, both commercial and individual. Her division has banking officers who speak different languages, including Chinese (Mandarin, Cantonese, and Taiwanese), French, Japanese, Korean, Tagalog and Vietnamese. Ms. Brow herself is fluent in Vietnamese and French and is conversational in Mandarin Chinese.

Born in Vietnam, in a village near Hanoi, Ms. Brow left Vietnam in 1959 with her parents and lived in India, then France before settling in the United States in 1965. She started her career working for the U.S. Postal Service in Washington, D.C. as a management analyst. From 1978 to 1982, she worked for the U.S. State Department at the U.S. Embassies in Moscow and Beijing, in the Budget and Consular Offices. Ms. Brow spent the next 21 years in Hong Kong working in commercial, investment and retail banking. She returned with her family to the United States and settled in Hawaii in 2005. Prior to joining Bank of Hawaii in May 2007, she worked for American Savings Bank as a management consultant. Ms. Brow obtained her Bachelor of Science and MBA degrees from the University of Maryland.

For these reasons, Ms. Brow is an excellent candidate for the Language Access Advisory Council and should be confirmed as a member.

I strongly support the JGO's confirmation of Mrs. Anh "Betty" Brow's nomination by Governor Lingle to the Language Access Advisory Council.
