I took over the management of the Hashimoto Persimmon farm when my parents retired in 2000. I retired in 2004 and worked full-time on the persimmon farm where we have 500 trees on 5 acres of land.

In October of 2007, Mayor Charmaine Tavares asked me to be her Agriculture Specialist. I accepted the offer because I knew I could make a difference because of my strong agricultural background and connections in the agriculture community, including the Farm Bureau.

Again, I am honored to be nominated to become a member of the Hawaii Board of Agriculture. I want to keep agriculture viable. I want to see sugar and pineapple survive. Most importantly, I want to see diversified agriculture thrive. Many third and fourth generation farmers are quitting because of the hard work, low profitability and the strict regulations that needs to be followed. Everyone talks about sustainability but we need agriculture to be viable to be able to become sustainable.

I am in very strong support for Clark Hashimoto's appointment to the Board of Agriculture.


