This has given me a wide range of experiences in dealing with political, ecological, environmental and economic issues. This includes irrigation and water rights issues in both New Zealand and Oregon. 1 believe that these experiences, coupled with my experiences living in Hawaii would be useful in attempting to administer the State of Hawaii's Water Code as a member of the Commission on Water Resource Management.

Senator Hee:

Thank you for your letter dated March 23, 2009 (received March 27, 2009). I appreciate your taking time out of your busy schedule to personally send me a letter.

In response, I will attempt to answer your questions to the best of my abilities.

2a) Why do I wish to be on the Commission:

I firmly believe in the importance of this commission and its actions as it deals with the future of our great State. The implications of water resources in an island environment are clear and unyielding.

2b) How do I perceive the roles and responsibilities of the Commission:

I view the role of this Commission is to help the State of Hawaii enhance and protect its precious water resources by properly administering the State Water Code of 1987.

The Commission on Water Resource Management has the responsibility to administer the water code with honesty, fairness and effectiveness. It also has the responsibility of understanding the full intent of the water code legislation, so that it can make its decisions based on this intent.

Ultimately, the Commission must do its best to ensure that the people of Hawaii have clean and productive water resources for future generations.

2c) Why I believe that I am qualified for the position:

As a lifelong member of the community at large and as a business-person on Maui, I have watched with great concern the issues surrounding our State's water issues. I have become extremely aware of the social, cultural, environmental and economic issues that all must be taken into account when dealing with our finite water resources. I am well aware that the economic stability, cultural heritage, environmental integrity and agricultural security are all contributors and affected aspects of our water dependence.

My experience's at Ulupalakua Ranch have lead us to be very proactive in native reforestation, for no other reason than for the long term security of the water cycle in our area. Living in one of the semi-remote areas of Maui, I have been very aware of the cultural issues that are associated with our water resources. I am also very conscious of the importance of water in the short term and long term implications that it has on all of the aspects of our economy.

In our operations in Oregon and New Zealand, we manage irrigation systems. In doing so, I have become familiar with different aquifer systems and water laws in different parts of the world. I believe that this combined with my roots in Hawaii would give me a unique perspective if I was on the Commission.

2d) What do I hope to accomplish on the Commission:

I do not see my role on the commission to be about any personal accomplishments. I see my responsibility as being the administration of the water codes and laws. I would hope that while on the Commission, the body would be seen to administer these codes in such a way that every commissioner and the people of Hawaii felt that we had served the State well and accomplished our responsibilities.

2e) Three personal qualities that would benefit the Commission:

<u>Integrity</u>: I firmly believe that it is my duty and responsibility as a commission member to study and understand the issues that come before us so that I can make an honest and educated decision. If I were on the Commission I would never make a decision if I did not understand the issues nor was sure of my decision.

<u>Honesty</u>: I will not enter into any situation (business or personal) that I find to be unethical or dishonest. If on the commission, I would never knowingly enter a decision that I believed to be unethical or dishonest nor one that could be used against the people of Hawaii in a negative way.

<u>Fair/Open-minded</u>: I have always believed in keeping an open mind to all sides of an argument. My experiences in life have led me to understand that no two people see the world in exactly the same ways. We all see situations differently and have different degrees of belief on different issues. I believe that it is important for members of boards and commissions to always make their decisions in as objective a manner as possible, and this can only be achieved by listening with an open mind to each of the views that are presented to them.

2f) Previous experience that would benefit Commission:

I believe that my time on the State Board of Agriculture would be very beneficial to this Commission. I also believe that my business and life experiences inside of and outside of Hawaii would be very beneficial to the Commission. I believe all of these experiences give me an understanding of the responsibilities of being on a commission as well a deep understanding of the cultural, environmental, agricultural and economic issues that would be necessary in making the kinds of decisions that would come before the Commission on Water Resource Management.

2g) Foreseen conflicts of interest:

The only potential conflicts of interest that I could potentially see, is my sitting on the Central Maui Soil and Water Conservation District Board. I will be resigning from my position on the Central Maui Soil and Water Conservation Board immediately – so as to eliminate any potential conflict off interest on this issue. Furthermore, being that Ulupalakua Ranch has no perennial streams or rivers running over/through it, I do not see any issues arising from my position with the Ranch.

However, if for some unforeseen reason an issue did arise in which I had a conflict of interest – I would quickly disclose this conflict and recuse myself from any discussions and decisions on that issue.

On behalf of the Department of Land and Natural Resources (Department), I would like to express my support of the confirmation of Mr. Sumner P. Erdman to serve on the Commission on Water Resource Management (Commission).

The Commission is required by law (Section 174C-7, Hawaii Revised Statutes) to select commissioners through an open, competitive process. An independent nominating committee composed of two (2) members selected by the Governor, one (1) by the Senate President and one (1) by the House Speaker shall solicit candidates typically by placing an ad in the papers across the State, in the monthly bulletin of the Commission, and on the Commission's website. The nominating committee reviews the applications, conducts interviews if desired and sends to the Governor the names of at least three individuals for consideration.

The nominees, by law, must have "substantial experience in the area of water resource management." In his capacity as the president of Ulupalakua Ranch, Mr. Erdman actively promoted native reforestation for the express purpose of ensuring the long term health of the Ranch's water resources. He also has served as the director of the Central Maui Soil and Water Conservation District, which works to preserve our valuable land and water resources.

Mr. Erdman is a graduate of the University of Puget Sound (1988), and has completed the University of Hawaii's Agricultural Leadership Program and Stanford University's Executive Business Leadership Program.

Mr. Erdman has served on numerous boards and commissions in various capacities. He is the founding director of the North American Elk Breeders Association, has served as both president
