I was born and raised in Lahaina, Maui. I grew up in that once rural plantation town. I attended and graduated from Lahainaluna High School, whereby, I developed a liking to agriculture. I went on to Utah State University where I graduated with a BS in Plant Science/Agronomy.

I am 5 years retired from the USDA-Natural Resources Conservation Service. The 32 years I spent with the agency on Maui, Molokai, and Kauai with responsibility to Niihau, Lanai and Kahoolawe made me aware of how different each island can be. The hands on or field approach we had with farmers, ranchers, plantations, taro growers and even urban landscapes gave me a first hand view of our natural resources.

The last 3 % years I spent on the Commission on Water Resource Management was a learning experience. I remember in the late 70's-early 80's, Mr. Ed Sakoda of the newly developed CWRM staff gave a briefing to our agency on their responsibilities. I believe they had 2-3 staff persons then, and I wondered how they could operate? It has been nearly 30 years since, and I can see the work that went into the data base they have accumulated. Yet, there is more to accomplish.

I have noticed the many irrigation systems, stock water pipelines, reservoirs I designed; several taro auwai ditch flows I measured, stream diversions I viewed, streams I hiked looking for non-point pollution sources, and developing water shed plans that included flood prevention and irrigation pipelines are directly in line with many of the issues before the commission.

The challenges before the commission are still many. Water is becoming an ever important issue, more so on the island of Maui. Agriculture was always the mainstay of surface water use throughout Hawaii. Today, we need to have a balance for the availability of water. Decisions do not come easy, however, we have the State Water Code to guide us and hopefully, some common sense to assist us.

I surely welcome another term on the Commission on Water Resource Management. I have been a civil servant throughout my working career and would continue serving the people of Hawaii honestly and fairly. I humbly ask for your support on my nomination to the Commission on Water Resource Management.

GOVERNOR'S MESSAGE 517 – SUBMITTING FOR CONSIDERATION AND CONFIRMATION TO THE COMMISSION ON WATER RESOURCE MANAGEMENT, GUBERNATORIAL NOMINEE, NEAL S. FUJIWARA, FOR A TERM TO EXPIRE 6-30-2013

On behalf of the Department of Land and Natural Resources (Department), I would like to express my support of the confirmation of Mr. Neal S. Fujiwara to serve on the Commission on Water Resource Management (Commission).

The Commission is required by law (Section 174C-7, Hawaii Revised Statutes) to select commissioners through an open, competitive process. An independent nominating committee composed of two (2) members selected by the Governor, one (1) by the Senate President and one (1) by the House Speaker shall solicit candidates typically by placing an ad in the papers across the State, in the monthly bulletin of the Commission, and on the Commission's website. The nominating committee reviews the applications, conducts interviews if desired and sends to the Governor the names of at least three individuals for consideration.

The nominees, by law, must have "substantial experience in the area of water resource management." Mr. Fujiwara has been a member of the Commission since 2005. During his term, he has been involved in numerous water management decisions brought before the Commission. These include the designation of Na Wai Eha on Maui, the first surface water management area in the State; the establishment of interim instream flow standards for East Maui; the adoption of the 2008 Water Resource Protection Plan; and actions on water use permits from across the State.

Mr. Fujiwara retired as the Maui District Conservationist from the United States Department of Agriculture (USDA), Natural Resources Conservation Service (NRCS), after 32 years of government service. As Maui District Conservationist, his program areas covered the Islands of Maui, Molokai, Lanai, and Kahoolawe. After graduating from Utah State University in 1971, Mr. Fujiwara briefly worked for Pioneer Mill Sugar Co. before joining the USDA in 1972 as a

trainee on Maui. He was transferred to Molokai to assist in the local field office, where he established the Plant Materials Center in Hoolehua. During his career, Mr. Fujiwara also served as District Conservationist for Kauai and Soil Conservationist for Kauai County.

As Maui District Conservationist, Mr. Fujiwara administered a multitude of natural resources conservation programs to help reduce soil erosion, enhance and conserve water supplies, improve water quality, increase wildlife habitat, and reduce damages caused by floods and other natural disasters. The NRCS partners with many federal, state, and local government agencies, as well as non-governmental entities to deliver their programs. Along with his extensive technical knowledge of irrigation systems and expertise in conservation and watershed planning, Mr. Fujiwara also brings a spirit of partnership and cooperation to the Commission.
