1. What skills, qualifications and expertise have prepared you to serve as a board member of RCUH?

My formal education is primarily in business management. This includes a BA in Economics with a minor in Business Administration, an MBA (from the Univ. of Hawaii), and a 9-week executive education program at Harvard Business School that specifically focuses on issues of top management; ie. strategy, technology & innovation, risk management. Thus, I have the formal skills that will facilitate proper oversight of RCUH.

In addition to my educational qualifications, I have substantial and diverse experience in starting up, operating, managing, acquiring, selling, and merging businesses. I have personally managed a portfolio of businesses with annual revenues of about \$75M, with a few hundred employees. My experience also includes substantial hands-on experience managing technical projects and people; the principal job of RCUH. My experience also includes working with large defense contractors, government agencies, and military and congressional officials. I have first-hand knowledge of government contracting procedures and regulations.

Finally, I am a long time Hawaii resident with a strong sense of community and a deep appreciation for the tremendous value that a robust research enterprise can add to the community.

2. What are your top three priorities as a board member? What short and long term goals do you have for RCUH?

Priorities:

- 1. Be an effective and efficient project execution organization as measured by our customers.
- 2. Promote UH and RCUH as a top-tier R&D organization, enhancing its ability to win grants and research contracts.
- 3. Facilitate the flowdown of benefits from UH/RCUH to the community with respect to enhancement of educational, employment, and economic/entrepreneurial opportunities

Short Term Goals

- **1.** Ensure UH/RCUH is cognizant of, and pursuing, new opportunities available as a result of the federal economic stimulus package.
- 2. Ensure RCUH has systems, especially software infrastructure, that will allow it to function at maximum efficiency. This should be combined with metrics of performance, and a management team that has real world experience.

RCUH

Long Term Goals

- 1. Ensure that RCUH remains independent of UH's administrative policies and procedures so that it can operate like a business; and that its primary mission of providing support services to the research and training mission of the University does not get diluted.
- 2. Establish UH/RCUH as a "go-to" organization for large-budget R&D sponsors.

3. As you know, the President of the University of Hawaii also serves as the President of RCUH. In the coming months, the University of Hawaii Board of Regents will be called upon to select a new President. What qualifications to believe the Board of Regents should consider most important with respect to RCUH's mission?

The new President of the University should view the research, work force development, and economic development missions of the University with the same importance as the educational and community service missions.

4. What role, if any, do you see RCUH playing in the State's effort to recover from the current economic crisis?

RCUH can play a critical role in the management of federal stimulus funding, especially for research and training. I believe that the National Science Foundation will be providing additional funding for existing programs, and RCUH's current services will allow UH to take full advantage of that funding. I also understand that there is funding for workforce development in green jobs, healthcare, and information technology. RCUH can help UH and state and county agencies identify, secure, and manage that additional funding.
