#### Norman S. Stahl, Ph.D.

### Nominee for the Advisory Board on Veterans' Services

Chairman Espero, Vice Chairman Bunda, and members of the Senate Committee on Public Safety and Military Affairs, I thank you for the opportunity to speak about my interest in, and qualifications for, service on the Advisory Board on Veteran Services as you consider my confirmation to that board. In my remarks, I will address the questions posed by Chairman Espero in his letter dated March 27, 2009.

First, I would like to tell you why I am interested in serving on the Advisory Board on Veterans' Services. The answer is simple. In the summer of 1969, I completed a 13-month tour of duty as a young officer of Marines in the Republic of Vietnam. I was fortunate enough to come home with no wounds and in relatively good mental health. It is my belief, that having been spared significant trauma, I owed my God and my Country a debt that could only be paid by service to others. I continued to serve my country as a Marine on active duty for 22 years and retired as a Lt. Colonel of Marines – 20 years ago last October. Serving on the State Advisory Board on Veterans' Services offers me a way to continue serving others in a capacity that is consistent with my age and current level of physical ability.

If confirmed as a member of the Advisory Board, I see my responsibility to reach out to and connect with the veterans of East Hawaii, solicit their concerns, listen to their grievances and recommendations, and communicate them to Director Moses and the members of the OVS Advisory Board. I believe it will also be appropriate for me to be active in discovering ways that Hawai'i can better serve its veterans and to recommend changes in law and policy through Office of Veterans' Services.

We are at an interesting point in history, where we have veterans from World War II, Korea, Vietnam, the Cold War, Desert Storm, and the Global War Against Terror. Each of these populations has different needs, but all have served their country in perilous times and deserve to have their concerns addressed. I hope to be a Board member, who communicates with veterans of all eras, lets them know of benefits available to them from the State and the Federal government, and holds their issues up to the appointed and elected officials of our State.

The Chairman asked me to name three qualities that describe me and illustrate my ability to benefit the Advisory Board. As you may have noted from the one-page resume that I submitted with my testimony, in addition to being a veteran, I am a trained and experienced counselor and an educator. My status as a veteran and affiliation with other veterans gives me an appreciation for the sacrifices they have made and a commitment to serve them. My experience as a counselor has given me interpersonal and group communication skills that enable me to clarify issues of people who are struggling with personal burdens, and through committee work in

higher education, I have developed the ability to help forge consensus from divergent views. I believe that each of these talents enhance my ability to serve my fellow veterans, the Director of OVS, and my fellow Advisory Board members.

I have been asked to describe an experience that would make me stand out and would illustrate my ability to benefit the Advisory Board. As you may know, I am a member of the Governor's Advisory Council for East Hawai'i. I recall a time at one of our community meetings; we were listening to concerns being expressed by Beneficiaries of the Hawaiian Homelands trust. Over a period of about 90 minutes, we heard from 15 to 20 spokespersons from the Hawai'ian community. Some speakers were eloquent and profound and others were less than eloquent and profane. The community members comprised different generations, diverse occupations, varied life circumstances, and addressed diverse complaints and issues. As the time for closing of our meeting approached, the room was emotionally charged. I could sense that the beneficiaries were frustrated because they were not sure that their message had been understood. Calling on a skill that counselors refer to as "reflective listening" or "clarifying, I addressed the group using words to the following effect:

"We have heard from many people tonight. You (pointing to an individual) spoke to us about frustrations arising from interactions with officials of DLNR as it related to operation of your farm; You (pointing to another) spoke of your strong opposition to the proposed building of a super store on Hawaiian Homelands, You (pointing to another) spoke of a unfilled campaign promise in which the Governor said that Hawai'ians could live on the Homelands in tents if they desired, (and so on). These are seemingly very different issues, but the common thread that I heard in all of them is that you would like us to tell the Governor that you want OHA and other State officials to pay attention to the Beneficiaries, solicit your concerns and advice and give them serious consideration before making decisions that impact the Homelands or its Beneficiaries."

The tension was broken. The people in the room broke out in applause and one of the speakers said, "You ought to be the Governor". Senators, I assure you, I have no desire to be the Governor. However, I believe this example illustrates my ability to listen effectively to concerns of people who may be frustrated, angry or disillusioned and to reassure them that their concerns have been heard and understood.

Finally, I would like to state unequivocally that I am not aware of any possible conflicts of interest that might arise during my service on the Advisory Board on Veterans' Services.
