COMMISSION FOR NATIONAL AND COMMUNITY SERVICE

1. What qualifications and experiences do you have that will benefit the commission? How has your past volunteers and community service activities/leadership roles prepared you for this position?

I have been an active volunteer in Hawaii for more than 25 years. As a teenager, my parents and grandparents taught me to always be grateful for what I had and to always "give back" to show my appreciation. As a teenager attending University Laboratory School, I would always volunteer for community and international relations events and projects and participated in numerous activities, ranging from visiting various community and senior centers to assisting with holiday projects. I also participated in exchange programs with students from Japan, and I continue to stay active with learning and mentoring projects such as "Japan in a Suitcase." Through the Japan America Society of Hawaii, I would visit various elementary schools and teach them about their counterparts in Japan using hands on activities and personal experiences as a JET participant from 1997 through 1999. While in Japan, I volunteered with the Special Olympics, coaching basketball, softball and assisting with other community events and projects, especially those that involved working with the youth and seniors of my community.

Upon my return from Japan, I returned to coaching and officiating basketball, volleyball and softball in my community. Because my involvement was year around, I knew all the "ins and outs" of what the expectations were of each coach, parent, child, official and members of the board. Because of this knowledge, I was asked to join the board of directors while also maintaining my head coach and official positions. In this new role, I used patience, understanding, compromise, and communication to gain insights into what each organization participant expected from the other members. Throughout my years of volunteering in my community, I have realized that more often than not there is no right or wrong way of doing things; we all must work together if we are to achieve our goals, making do with what resources we have and working with local organizations within our communities to provide both monetary donations and volunteers.

While working with the Manoa Youth organizations, I became familiar with the Manoa Waioli Lions Club where I have served as an active member for more than seven years. During my time at this wonderful organization, I have learned to truly appreciate what various service organizations do to help keep community programs, events, projects and activities prospering and flourishing. Through organized volunteering, individuals can come together to make a real difference, especially from organizations that are solely dedicated to helping others, such as the Hawaii Commission for National and Community Service (HCNCS). HCNCS dedicates itself to supporting, nurturing and developing its commitment to serve the children, their parents and seniors of Hawaii. I too strongly believe this or I wouldn't have accepted this nomination.

As a member on the Board of Directors for the Moiliili Community Center, I see firsthand the need for assistance in our elder care and senior care programs. Unfortunately, due to funding restrictions, our elder care program was terminated last year, but our senior program continues to flourish thanks to private donations and funding. Our children's program is self sustaining and very successful.

I also believe that it is important for everyone to be able to read and was privileged to serve as a member of the Hawaii Literacy Board of Directors. There, I was very active with the family and children reading

centers at Kuhio Park Terrace and Mayor Wright Housing and also provided assistance with locating funds to maintain our Adult Literacy program.

Because of my involvement with youth programs and community service organizations, I was asked by a former Executive Director of the Boys and Girls Club to assist in finding funding for their annual Girls' Invitational Basketball Tournament. Instead of securing funds from outside sources, I took it upon myself to sponsor the tournament for three years until other sources of funding could be secured. The investment was worth every penny. The participants are always very thankful and many have said that it has kept them "out of trouble" by giving them a positive place to go every day.

While working with the annual Girls' Invitational Basketball Tournament, I could see that these young people craved mentorship. To address that need, I established a mentoring program in conjunction with the Boys and Girls Club Leadership Program. The youth first completed the Leadership program and were then matched with mentors from the Plaza Club's Young Professional Group. Pairings were based on questionnaires filled out by the teens as to what their interests were and what profession they were interested in pursuing. For three months during the summer, each participant would shadow their mentors at work, meetings and various functions. At the end of the program the youth and their parents were invited to a party at the Plaza Club to celebrate their accomplishments.

Although everyone involved was touched by the experience, it wasn't without its challenges. For instance, many of the teens did not have the proper attire to shadow their mentors in a professional environment. To address this issue, I asked members of the Plaza Club to sponsor the teens by providing monetary donations, and in return, each member who donated \$25 or more was given a complimentary buffet and had their names posted in our monthly newsletter. In addition, I approached Hilo Hatties with our dilemma, and they graciously provided the participants with discounts on their Aloha attire. With the donations from the Plaza Club members, we not only purchased Aloha wear, but we were also able to purchase gifts for each participant. Everyone who donated was inspired and many were reminded of when they were first beginning their careers.

Because of my lifelong commitment to giving back to the community and my ability to help youth and service organizations secure proper funding, I believe I can be a valuable asset to the Commission. Trying to secure volunteers in a struggling economy where volunteers are a scarce commodity is also a challenge that I face every day as a member of the Moiliili Community Center Board of Directors. As a Commissioner, I will need to use all the resources and connections gained throughout all my years as a volunteer to enrich and grow volunteerism in Hawaii. We will all need to support, cooperate and be patient with each other and achieve our goals. I have worked in the most temperamental situations where leadership started to fall apart, and I was able to step in and help everyone take a deep breath and reflect upon why we were all there. It is not always an easy process when it comes to prioritizing and allocating funds to various organizations. However, through a grassroots effort, utilizing all that is available through corporate, local and national efforts, I think HCNCS will continue to be successful in maintaining its commitment to serving Hawaii's people.

2. What initiatives would you recommend to increase community service participation for all ages?

Because HCNCS is administratively attached to the University of Hawaii, Office of Student Affairs, I would reach out to them first and ask them to assist in collaborating with campus organizations such as

fraternities, sororities and intramural sports teams to come together and volunteer. We all need to look at creative ways of obtaining volunteer assistance, such as using incentives to get young people involved in volunteering. Perhaps we can look into the possibility of making "volunteering," an extracurricular or lab credit.

Next, I would look at local organizations that are self sustaining and ask them to participate in their local community groups. While it might not be easy to gain their support, we will need to reflect on what has been done successfully and use that knowledge to help other organizations improve their operations.

I would also look to our local schools for assistance. Sometimes, we appeal to businesses for assistance, and fail to see the potential children have. We are supposed to lead by example, and if we show children the joy of giving, they will be inspired to help others as well. Giving back does not always have to be in a monetary form; physically volunteering is indeed priceless as volunteers are a hot commodity in today's struggling economy.

We will need to look at past recipients of HCNCS' assistance and ask that they please donate their time to other organizations in need of help. Whether it is through fundraising efforts or assisting with programs, projects or events, any help would be appreciated.

We can also turn to community and senior centers for help. While many assume that seniors only want to receive assistance, my experience has been that they are always willing and eager to "give back" to their community. They have a lot to offer; all we need to do is ask and listen to what they have to say.

Groups and organizations need to help themselves before getting help. In these tough times where money and volunteers are scarce, only organizations that are willing to make the effort should be rewarded with additional assistance. If organizations are unable to help themselves we will need to research why that is and offer assistance on how they can effectively reach their goals.

When we use each others' knowledge, connections and talents for good, we all benefit.

3. What would be your top three priorities for the commission?

My number one area of focus is our unique "family" culture in Hawaii. We have families that are blood related, but we also have our "hanai" families that are also very strong and united in the same beliefs and values. We all help each other in times of need which, of course, is not unique to our state. But what is different in our State, is that we here in Hawaii, can be complete strangers willing to help each other in times of need. A neighbor is someone who not only lives next door to you, but someone who lives a block or two away. There is a special "trust" that resides in our State, that no other state can claim with pride and confidence. We need to use this special connection we all share to build our communities and make them stronger and safer. We need to rid each community of the "trash," crime, violence, graffiti, homelessness, etc., that is taking over some of our communities. We must all come together in a collaborative effort, uniting in our common goal to make Hawaii stronger and safer. We need to share in our commitment to create self sustaining organizations that in turn, will help guide and lead the way to more prosperous programs that help our most vulnerable. We need to ask and encourage greater participation when it comes to community service. Our children, seniors and family need to prosper for the good of Hawaii and through HCNCS they will. I would like the opportunity to be a part of this effort.

Second, I would help organizations that fit the criteria to receive assistance from DLIR's OCS and any other grant opportunities available. Many organizations do not look for grants and other forms of assistance because they may not know the process for doing so. I understand that the Commission has been faced with a number of challenges from OCS, and I would like to make certain that all aspects in this area of funding are on track and focused to help the numerous entities that need it. When I was a director with Hawaii Literacy, our Executive Director was unaware of some of the programs that OCS offered assistance to. Because I knew a little about the various program grants available, we were able to, with great effort from all involved, receive a substantial grant for our book mobile that helps many in the Leeward district, which includes homeless children along the coastlines of Nanakuli and Waianae. Because there is no electricity on the beaches, the children had nowhere to go to study. The book mobile was the perfect solution, it has a generator that allows for a safer well lit environment and came equipped with a computer for the children to use.

Third, I believe that neighborhoods must take it upon themselves to keep their communities safe, clean and free from drug related activities. Everyone must take pride in where they live and take the initiative to stand up to the "trash" that destroys their communities. Any one of these factors can contribute to a safe and comfortable neighborhood, or just the opposite. Public safety is one of my top concerns. As a member of my neighborhood board, I know firsthand what it is like to hear stories of violence and home invasions. We must all work together as a united community dedicated to the good of our neighbors and the safety of all. With help from leaders of our State, City, local businesses, schools and neighborhood boards and organizations such as the Rotary and Lions Club, I will work to educate individuals and leaders within each community.

4. What impact do you think the current economic recession will have on volunteerism and what challenges and/or opportunities will the commission face during these times of economic uncertainty?

Demand on volunteer organizations will increase as funding decreases. There may be a lack of volunteers as some may need to find a second or perhaps third job to simply pay their bills and thus unable to volunteer.

There will inevitably be more competition for funding and HCNCS will have to make "tough" decisions and implement stringent criteria that best meet the needs of the community. By maximizing the impacts and looking for something more than personal gains, the Commission will have to take precedence when selecting which organizations or groups to help.

As I mentioned earlier, as a member of the Moiliili Community Center Board of Directors, we needed to make the difficult decision of terminating our elder care program. As difficult as this was, it was necessary to keep the Center itself flourishing. Our largest participation group is our children's program; which is self sustaining. Unfortunately, this is the norm in these tough economic times, only programs that are self sustaining have the best chance of continuing. The Commission will and should be busy researching and thoroughly looking into which programs are capable of being self sustaining with the help of the Commission. We will have to be very selective and scrutinize organizations that request our assistance and unfortunately we will have to turn away some if not most.

As a Commissioner, I would like to search for resources that can form an assistance program that can help programs that are not quite at the level of self sustaining but can be with the proper guidance and help. I understand the Commission already has partnerships within the grassroots and other areas within communities, but we need to search further if at all possible; especially with current economic obstacles.

Finally, I believe that there are people who understand the plight many volunteer organizations face in these tough economic times. Many of these people will try harder to help physically as opposed to monetarily, which is what many organizations need. Experience and time cannot only be measured in dollars; we need to accept the effort of those willing to help in any way or form.

Despite these tough economic times, the American Spirit of volunteerism shall continue to thrive. As a member of the Hawaii Commission for National and Community Service, it will be an honor and privilege to help facilitate Hawaii's efforts to give back to the community.
