Chair Hee, members of the Senate Committee on Water, Land, Agriculture and Hawaiian Affairs, thank you for this opportunity to present background about myself in your consideration of my confirmation to the Board of Land and Natural Resources (BLNR).

I have lived in Upcountry Maui for the past 18 years. I have an engineering degree from the University of California, Santa Barbara where I graduated with honors. All my children are born and raised on Maui and together we spend a fair amount of time in and around State parks, the shoreline, and other outdoor areas.

In the last 18 years I have had the opportunity to understand, appreciate, and participate in crafting and implementing public policy in Hawaii. As the former Director and Deputy Director for the County of Maui's Department of Public Works and Environmental Management, I worked closely with the County Council, the public, and our employees to implement dozens of actions. These actions were all focused on delivering better public services while improving the environment. After working for the County, my involvement with government continued as a member of the Hawaii 2050 Sustainability Task Force, and being a frequent contributor to County issues that affect affordable housing, permitting, and water use. A position on the Board of Land and Natural Resources would give me the opportunity to continue to work with the public on bettering our State in the preservation and careful management of its resources.

My company, KSD Hawaii, is a Maui based real estate construction, consulting, and development company. Our projects are primarily on Maui, though we have done and are doing work on the Big Island and Oahu. Previously, when I worked for Schuler Homes, I worked on Maui, Oahu, and Kauai.

I truly look forward to working with the Board to bring my private and public sector skill set, knowledge of land management matters, and a broad understanding of many of the issues common to all islands. I ask for you to support my nomination to the Board of Land and Natural Resources.

Response to Written Questions

(a) Please explain what you feel is your most important contribution to the Board of Directors of Land and Natural Resources?

One of the most important contributions I can make to the Board is bring an understanding of both the private sector's ability to handle certain permit or lease conditions and the department's responsibility to enforce, monitor, and otherwise manage certain permit conditions. A balance must be struck, when possible, without overwhelming the applicant into possible failure and protecting the public interest.

(b) What unique qualifications do you have that has made a defining difference as a member of the Board of Directors of Land and Natural Resources?

Though I haven't yet served, I believe my experience in both the public and private sectors in upper management level positions will define my time on the Board, if I am confirmed to serve.

(c) What action have you taken as a Board of Directors of Land and Natural Resources member that best describes your philosophical view?

If allowed to serve, my philosophical view will be one of balanced decision making, listening to the public and incorporating reasoned solutions.

(d) Please explain the single most important action the government can take to improve your vision as a member of the Board of Directors of Land and Natural Resources?

As someone who does land management, I am aware of the multitude of issues and opportunities that any land owner can face. In this regard, where there are instances where government can shore up processes, techniques, and enforcement, I would hope that government, in any branch, would take such necessary actions.

(e) Please explain what you believe to be the single biggest task that the Board of Directors of Land and Natural Resources must take action on?

Having reviewed the last 12 months of Board agendas, the Mauna Kea management plan appears to be a very important issue for the Board to act on. In general, given the vast

amount of lands managed by the Department, I want to learn more about any shortfalls the Department may have in land management and assist in helping them better manage those lands.

(f) Can you foresee any possible conflicts of interests that could arise during your service on the Board of Directors of Land and Natural Resources? How would you overcome any possible conflicts of interest?

A possible conflict of interest will be my company's occasional consulting on the Kaheawa Wind project for First Wind, Inc. In this case, and any similar case that may come before the Board, I will recuse myself from voting.
