Aloha Chair Jon Karamatsu and Vice Chair Ken Ito, and members of JUD.

I am Elizabeth Royos, an officer of the Hawaii Game Breeders Association. I strongly oppose HB 1513 that would criminalize sharp objects and could be attached to a cock's foot.

This bill is too vague to withstand constitutional scrutiny. It also violates the Hawaii Constitution because it is in violation of the cultural exception that protects cockfighting that is a well established cultural practice.

I am a Filipino American and I should have the right to preserve and protect my cultural heritage. This is getting increasing hard to do since in even predominantly Filipino districts, there is no Filipino representation. Our culture, language, customs and traditions are slowly being eroded as Hawaiians and Filipinos are under-represented.

THERE ARE MANY OF US WHO WANT TO KEEP THESE MEMORIES ALIVE IN THE POSITIVE LIGHT AND NOT THE NEGATIVE ONE THAT A LOT OF PEOPLE HAVE MISUNDERSTOOD COCKFIGHTING TO BE. YOU WOULD BE AMAZED AT HOW MANY GREAT GRANDPARENTS, GRANDPARENTS, AND IMPORTANT FIGURES OF THE COMMUNITY WHO HAVE FOND MEMORIES AS WELL. WE WANT OUR YOUTH AND THE PEOPLE WHO HAVE NOT GROWN UP AROUND COCKFIGHTING TO KNOW WHAT WE KNOW. COCKFIGHTING BACK IN OLD HAWAII WAS NOT ILLEGAL, WHEN THE MISSIONARIES ARRIVED IN THE ISLANDS THEY PERSUADED KINGDOM LAW TO RECONGNIZE GAMING AS ILLEGAL. THUS MAKING GAMING IN COCKFIGHTING ILLEGAL AND NOT THE ACTIVITY. THE COMMUNITY THAT DOES NOT UNDERSTAND THE CULTURE OF COCKFIGHTING NEEDS TO REALIZE THAT COCKFIGHTING BECAME CORRUPTED BY INDIVIDUALS WHO DECIDED TO LISE COCKFIGHTING AS A VENUE TO DEAL DRUGS. BUT WE HAVE DRUG DEALING AND GAMBLING LINKED TO EVERY OTHER SPORT YOU CAN THINK OF BUT ITS NOT MADE INTO SUCH A HUKE DEAL BECAUSE FOOTBALL, HORSE RACES, BOXING TO NAME A FEW IS NOT CONSIDERED. ILLEGAL. WHAT IF THEY WERE? HULA AT ONE TIME WAS BANNED FROM THE HAWAIIANS AND BECAME AND UNDERGROUND ACTIVITY FOR ITS SO CALLED, "PORNOGRAPHIC" NATURE BUT WAS KEPT ALIVE BUT THOSE WHO BELIEVED IN IT. CAN YOU IMAGINE IF WE HAD NO HUILA? COCKFIGHTING NEVER WAS BANNED IN HAWAII. COCKFIGHTING HAS BECOME MISUNDERSTOOD AND MISREPRESENTED.

I AM A MAN WITH INTEGRITY AND PRIDE, I CONSIDER MYSELF TO BE A POSITIVE CONTRIBUTION TO THE COMMUNITY. THERE ARE MANY PEOPLE LIKE ME WHO CAN RELATE TO WHAT I AM TALKING ABOUT. IN MY FIFTY-SIX YEARS OF SEEING ACTUAL CHICKEN FIGHTS I HAVE NOT ONCE WITNESS DRUG USE OR DRUG TRANSACTIONS. THE PEOPLE THAT ATTEND THE CHICKEN FIGHTS I HAVE ATTENDED ARE ALL PEOPLE LIKE ME, HONEST HARD WORKING AND GENUINELY GOOD PEOPLE WITH A GREAT PASSION FOR CHICKENS. IN A 2002 ARTICLE IN THE MAUI NEWSPAPER THERE WAS A YEAR LONG SURVEILANCE OF COCKFIGHTS AND DURING THAT TIME QUOTED BY OFFICER KIYOTO OF THE MAUI POLICE SAID, OFFICERS DIDN'T OBSERVE ILLEGAL DRUG TRANSACTIONS AT THE COCKFIGHTS, "BUT THERE WERE KNOWN DRUG PEOPLE THAT ATTEND."

YES COCKFIGHTING IS A PART OF THE FILIPINO CULTURE AS IT IS MANY. YOU ARE SADLY MISTAKEN WHEN YOU SAY THERE IS NO EVIDENCE THAT IT'S NOT APART OF THE HAWAIIAN CULTURE. YOU OBVIOUSLY DO NOT KNOW YOUR HAWAIIAN HISTORY. THE ROOSTER OR MOA WAS USED AS MANY ANCIENT HAWAIIANS AMAKUAS, THEY STRONGLY BELIEVED THAT THERE TRUE WARRIORS SHOULD BE AS ADVANTAGEOUS AS THE ROOSTER. THE ALII'S USED A FEATHER HEAD DRESS OR MAHIOLE WHICH IS LIKE THE COMB OF THE COCK. THERE WEAPONRY THE KAKALA OR SPUR WAS USED IN BATTLE AND MANNERISM IN BATTLE WERE ALL THE SAME AS A ROOSTER AS WELL. ON THE BIG ISLAND THE MOST NOTED ALII, "UNI" YOU CAN FIND ACTUAL ARCHAEOLOGICAL OR SACRED SITES TODAY AND SEE, WHAT YOU CALL THE PENS OR THE CHICKENS PENS THAT CHICKENS WERE KEPT IN TRAINED. THEY ARE STILL LOCATED ON MAPS AND IN FACT ON THE STATE RESERVATION MAPS. SO THERE IS PHYSICAL EVIDENCE THAT THAT CHICKENS WERE APART OF TRADITIONAL HAWAIIAN SOCIETY

OF KAAUMOA.

PALOLO VALLEY ON DAHU WHICH WE CALL TODAY PUA KAAU OR KAAU CRATER IN PALOLO VALLEY ITSELF IS NAMED AFTER THAT FAMOUS ROOSTER WHO IS AN ANCESTRAL GUARDIAN OF THE ALI'I CLASS. THERE IS SO MUCH TO THE HISTORY OF THE ROOSTER AND COCKFIGHTING THAT STEMS TO THE GREAT KAMEHAMEHA WHICH DENOTES HIS GREAT WARRIOR SPIRIT. THIS IS SOMETHING THAT COCKFIGHTING AND THE ROOSTER SHOULD BE KNOWN FOR AND NOT IT'S ABUSED OUT COME OF DRUGS AND GAMING. I ASK YOU TO LOOK UP GREAT HISTORIANS LIKE DAVID MAO, ABRAHAM FORNANDA, KAMA KAO, HOI PID WHO WRITTEN TEXT IN THE 1800'S; YOU CAN FIND SECTIONS OF PAA'ANI OR MEA PA'ANI OR PLAY OR LEISURE. THEY WILL CLEARLY STATE HOW COCKFIGHTING WAS RECOGNIZED AS CULTURAL PRACTICES OF LEISURE AND GAME.

AS FAR AS GOOD OLE ABE, I KNOW IT'S NOT A STORY BOOK ENDING AND OF COURSE WHAT PERSON WOULD WANT TO BELIEVE THAT HONEST ABE WAS CHICKEN FIGHTING REFEREE. NOT A PICTURE PERFECT ENDING FOR SOME BUT HEY, HE LIVED IN THE FOREST SURROUNDED BY WILDLIFE AND GAME CHICKEN FIGHTING WASN'T ILLEGAL THEN. A STORE CLERK NOW SEEMS LIKE THE PRESIDENTIAL WAY OF GETTING HIS NICKNAME BUT TELL ME WHAT PRESIDENT DIDN'T HAVE SOME KIND OF PAST? YOU MAKE THE DECISION. GOD BLESS THERE SOULS, BEFORE PASSING ON, MY SONS FATHER IN LAW AND UNCLE REQUESTED TO HAVE CHICKEN SCULPTURES ON THIER HEADSTONES BECAUSE OTHER THAN THIER FAMILY THATS ALL THEY KNEW. CHICKENS WERE A WAY OF LIFE.

Subject: House Bill No. 1513, Relating to Offenses Against Public Order

I am Louis Kealoha, captain of the Narcotics/Vice Division of the Honolulu Police Department, City and County of Honolulu.

The Honolulu Police Department strongly supports House Bill No. 1513, Relating to Offenses Against Public Order.

In 1983, the City and County of Honolulu enacted an ordinance prohibiting the possession of gaffs or slashers that are commonly used in cockfighting. However, the other counties in this state still do not have any laws specific to the possession of gaffs or slashers. They currently arrest individuals in possession of gaffs or slashers under "possession of a gambling device."

Passage of this bill will bring continuity to the charging criteria regarding gaffs or slashers. It will also assist law enforcement by streamlining the identification of repeat offenders.

In Hawaii, it is not illegal to attend a cockfighting event, and it is not illegal to possess a fighting bird. According to the Humane Society of the United States, Hawaii ranks 46 out of 50 in the nation regarding cockfighting laws.

In 2007, the federal government enacted an animal fighting prohibition law that makes it a felony to illegally sell, purchase, or transport any knives, gaffs, or sharp objects between states that are designed and intended to be attached to the leg of a bird for use in an animal fighting venture. Passage of this bill will ensure consistency in the regulation of gaffs and slashers in the four counties.

Lastly, the proposed penalties include animal cruelty education or a prevention program. We support this as a means to prevent future violations.

The Honolulu Police Department urges you to support House Bill No. 1513, Relating to Offenses Against Public Order.
