Good morning Chair Carroll, Vice Chair Shimabukuro and members of the House Committee on Hawaiian Affairs. My name is Kalei Kailihiwa, Director of Ho'olako Like of Kamehameha Schools. Thank you for this opportunity to testify in support of the intent of HB1658.

Kamehameha Schools supports the efforts of the legislature to establish and administer educational pilot programs that aim to preserve, perpetuate and share Native Hawaiian culture and arts, such as traditional voyaging techniques.

Founded in 1887, Kamehameha Schools is a statewide educational system supported by a trust endowed by Princess Bernice Pauahi Bishop, whose mission is to improve the capability and well-being of Native Hawaiian children through education. We serve 5,400 K-12 students through campus programs on Oʻahu, Hawaiʻi and Maui, and 1,317 three-and-four-year-olds at 31 preschool sites statewide. We also provide scholarships to keiki attending other pre-schools.

We look forward to working more closely with the legislature, the Department of Education and other public and private stakeholders in the community for the benefit of the children of Hawai'i.

Testimony re: HB 1658 - Traditional Hawaiian navigation pilot program.

Aloha kākou,

Kamakakūokalani Center for Hawaiian Studies located in HawaiıDinuiākea School of Hawaiian Knowledge supports, with reservations, the establishment and administration by the Dept. of Education of a two year traditional Hawaiian navigation pilot program.

The first reservation has to do with funding as there is no clear funding support for this effort written into the bill (amount??).

The second reservation has to do with articulation with other programs involving traditional navigation. As a former crew member on board Hōkūle②a in 1985 (Aotearoa, Tonga and Samoa) and 1993 (Rarotonga, Tahiti and Hawai②i), I do know that the Polynesian Voyaging Society has an informal training program. In addition, there are two university level classes focused on aspects of traditional navigation, that have been taught for half a dozen years at KCHS and are presently being taught at Honolulu Community College as well as at KCHS.

Is there or has there been any consultation done with either of these programs in order that there not be any conceptual or other kind of conflict or disconnect that would arise out of the pilot program with these already established programs?

The last reservation has to do with the safety and appropriateness of the program. There is really no background information regarding the actual activities involved in the program or any information about who (what kind of credentials) will be developing the program?

Kamakakūokalani Center for Hawaiian Studies recognizes the value of learning the wisdom and practical knowledge of the ancestors and applauds efforts to bring this to the youth of Hawai\overightarrow{\text{lawai}\overline{\text{lawai}\overline{\text{lawai}\overline{\text{lawai}}}. We, however, caution legislators in supporting this bill to assess fully the importance of good logistical support for safety, practicality and the genuine nature of the content that will be taught in this program.
