Testimony of Roy Catalani, Vice President of Strategic Planning and Government Affairs, Young Brothers, Limited

Chair Souki, Vice Chair Awana, and Members of the House Transportation Committee:

Thank you for the opportunity to testify on House Bill No. 267 (HB 267).

Young Brothers, Limited (*Young Brothers*) supports the intent of the bill and offers comments regarding the scope of the statutory amendment proposed by this bill. The purpose of HB 267, which we support, is "to ease the interisland transportation of rental motor vehicles." The legislation proposes to accomplish this purpose by carving out interisland shipment of rental motor vehicles from certain documentation requirements. The exemption, however, applies only to drivers of vehicles traveling on an interisland ferry "if the interisland ferry has a written agreement with the owner of the rental motor vehicle."

Young Brothers believes that there is no rationale or rational basis for creating different vehicle documentation requirements, and/or competitive advantages or disadvantages, for different types of vessels under these circumstances and respectfully requests that this Committee amend the language of the bill to apply to any "water carrier authorized by the State of Hawaii Public Utilities Commission to transport vehicles interisland" rather than to only "an interisland ferry."

Young Brothers points out that, when a driver of a rental motor vehicle is unable to return with the vehicle on an interisland ferry, the rental motor vehicle may in effect be stranded on a neighbor island. For example, if a ferry sailing is canceled for adverse weather conditions and the driver returns to Honolulu by air, the rental motor vehicle is left behind. Since the interisland ferry's PUC certification is limited to the carriage of vehicles only when accompanied by a driver, the return voyage of the vehicle would very likely be booked with Young Brothers, which by statute must require presentation of certificate of registration or ownership, proof of motor vehicle insurance, and identification. The onus very likely would fall on ferry personnel to obtain these documents, as well as notarized authorization to ship the car.

To avoid this situation and "ease the interisland transportation of rental motor vehicles," Young Brothers suggests that the scope of the exemption proposed by HB 267 include shipment by barge as well (or, more precisely, as noted above, by any "water carrier authorized by the State of Hawaii Public Utilities Commission to transport vehicles interisland"). If this Committee is inclined to adopt this suggestion, we would be very willing to work with Committee staff to fashion an acceptable revision of HB 267.
