Chair Oshiro and Members of the Finance Committee:

On behalf of the leadership and members of the Hawaii State Senate, thank you for the opportunity to provide testimony in support of H.B. No. 302.

The Senate's 2009 operating budget request is \$7,125,681 and we respectfully recommend that section 1 of the bill be amended to reflect this amount. Due in large part to the Senate's paperless initiative, significant savings have been realized through the reduction and redistribution of work activities of temporary session employees, and reduction of the Senate Document Center copier leasing costs, paper purchases, and other supplies. In addition, the Senate has restricted out-of-state travel by Senators and staff, reduced funds for training and professional development, and deferred major purchases and staff salary increases, resulting in a 17.6% reduction in the Senate's discretionary budget.

The Senate appreciates the opportunity to testify on this measure and asks the Committee for its favorable consideration.

Chair Oshiro and Members of the Committee:

Thank you for this opportunity to testify in support of this bill but to reiterate our ability to absorb a 10 percent reduction from our current appropriation to \$2,619,684, as I testified at your budget briefing on January 6, 2009. We recognize the fiscal constraints the State faces and will expend funds only as absolutely necessary to carry out our constitutional and statutory mission.

I would ask for your consideration of two adjustments that I testified to at your January 6, 2009 budget briefing. The first is an amendment to Act 1, Session Laws of Hawaii 2008, the current legislative appropriations act, to lift the FY2008-09 Audit Revolving Fund expenditure ceiling to \$6,300,000 to accommodate the delays in contract execution we encountered last spring for a few FY2007-08 financial statement audits. The delays were caused by various glitches in the executive branch agencies, such as the non-closure of the prior years' books. The raising of the revolving fund's expenditure ceiling will NOT require additional funding—the funds have already been appropriated but were not spent last fiscal year because the contracts could not be executed before June 30, 2008. If this amendment is made, then a second adjustment would need to be made, to Section 8 of H.B. 302, which sets the expenditure ceiling for FY2009-10, to the same \$6,300,000, as a precaution in the event similar delays occur this spring.

Chair Oshiro and Members of the Committee:

I am Ken. H. Takayama, Director of the Legislative Reference Bureau. Thank you for this opportunity to testify in support of H.B. No. 302, which appropriates funds for the legislative branch of state government. Section 9 of that measure appropriates the funding for the Bureau for Fiscal Year 2009-2010.

Late last year, we were asked to try to reduce our budget by ten per cent from last year's appropriation. Accordingly, our budget for this year would be \$3,113,126, which includes \$85,000 (the amount included in our 2008-2009 budget) to cover the State's dues for the Council of State Governments, which the Bureau is directed to pay on behalf of the State each year. I believe this amount will be adequate to enable the Bureau to carry out our duties and responsibilities in the coming year.
