Re: H.B. 450 - Relating to Family Leave

#### I. OVERVIEW OF PROPOSED LEGISLATION

H.B. 450 proposes to amend the Hawaii Family Leave Law, Chapter 398, Hawaii Revised Statutes ("HRS") by allowing individuals to take Hawaii Family Leave when their child, spouse, parent, or reciprocal beneficiary is on military deployment.

This Act would take effect on July 1, 2009.

#### II. CURRENT LAW

Hawaii Family Leave Law is currently permitted only for the birth or adoption of child, or the care of a child, spouse, parent, or reciprocal beneficiary with a serious health condition.

#### III. HOUSE BILL

The Department supports the overall concept of this bill, but we are concerned about the cost implications generated by this proposal.

- 1. The Department recognizes the many challenges that military families face when a loved one is deployed abroad. However, the Department is concerned that this legislation may place an extra burden on businesses during these difficult economic times. The loss of productivity due to the absence of an employee for reasons not related to his or her own inability to work may prove too costly for Hawaii businesses to absorb.
- 2. The federal Family Medical Leave Act applies to employers with at least 50 employees, because the Hawaii Family Leave Law applies to employers with at least 100 employees, it is likely that nearly all employees covered by the Hawaii Family Leave Law already have job-protection under the Family Medical Leave Act. The Family Medical Leave Act also provides 12 weeks of protected family leave whereas the Hawaii Family Leave Law allows for 4 weeks of protected leave.

I am Major General Robert G. F. Lee, State Adjutant General. I am testifying on House Bill 450. This bill grants family leave to an employee during any calendar year during a military deployment.

We support House Bill 450 but would prefer House Bill 720.

If House Bill 720 is passed, it allows an employee to use family leave during any calendar year to provide family care and support during the military deployment of the employee's child, spouse, or reciprocal beneficiary, or parent.

Passage of House Bill 720 would strongly indicate to the members of the Guard, reserves, or armed services, including the Coast Guard, especially those that are currently deployed to Iraq and Afghanistan that Hawaii truly cares and supports their duty to State and nation.
