In strong support of HB632 HD1.

To honor the women who serve in the armed services it is only fitting to appoint male and women veterans to the State's Advisory Board and to require it in our state policy. As you know women need an advocate on the advisory board who can assess the needs of women veterans with respect to issues including, not limited to, compensation rehabilitation, outreach, health care, and other issues facing women veterans in the community.

I read the testimony by Office of Veterans Services quoting General Shinseki saying "veteran is a veteran". Without a doubt this has been taken out of context. STATE OF HAWAII OFFICE OF VETERANS SERVICES TESTIMONY ON H.B. 632, HD1, RELATING TO POLICY ADVISORY ON VETERANS' SERVICES

SENATE COMMITTEE ON PUBLIC SAFETY AND MILITARY AFFAIRS

Good afternoon Chair Will Espero, Vice-Chair Robert Bunda, and members of the Senate Committee on Public Safety and Military Affairs.

I am Mark Moses, Director of the Office of Veterans Services (OVS). I appreciate this opportunity to testify on the intent of H.B. 632, HD1 which requires the governor, in making appointments, to ensure that members of the policy advisory board on veterans' services represent all minority viewpoints, including issues of concern to women veterans.

The OVS does not support this measure. As presently constituted the nine voting member Advisory Board on Veterans' Services represents minority views of veterans through the appointment of members who are female (three), retirees from the active duty military (three), National Guard/Reserves (two), and ethnic minorities (seven). The board also includes ex-officio members representing positions of the DOD, DLIR, DHS, and DOH; other special members are representatives from VA Benefits, VA Medical, and a Federal Department of Labor, Veterans Employment Service member.

At the Directors invitation, a representative of the Yukio Okutsu State Veterans Home was previously requested to become an active participant on the Board to provide information and veteran input in resolving issues that may arise at the home. Passage of H.B. 687 relating to the Home as well as other pending legislation relating to the Department of Health, Hawaii Health Systems Corporation (HHSC) may further dictate this participation.

Given the above and our current economic circumstances, there is no need to pass this legislation since it duplicates what is presently in place, and would require a costly rulemaking process.

A few weeks ago, I met with General Shinseki, VA Secretary who while addressing the NASDVA conference in Washington, D.C., was adamant that a "veteran is a veteran is a veteran." All veterans are the same and are to be treated equally.

Thank you for this opportunity to speak on behalf of Hawaii's veteran community.
