## TESTIMONY OF THE DEPARTMENT OF TRANSPORTATION

HOUSE BILL NO. 865, RELATING TO TRANSPORTATION.

The Department of Transportation (DOT) opposes this bill.

There are numerous county plans in place, including general plans, community plans, community development plans, and traffic circulation plans. The potential for conflicts between these various county plans certainly exists. Conflicting county recommendations would seriously complicate DOT's ability to comply with these county plans. Furthermore, the DOT could be cited for violating a statute and its master plans invalidated, due to its non-compliance with these contradictory plans. In addition, county plans occasionally lose sight of the intent of DOT's highway facilities. They recommend numerous accesses along these state highways, which slows traffic and defeats the purpose of DOT's regional transportation facilities. The DOT prefers that its plans maintain the intended integrity of its regional transportation facilities. This will ensure that our plans accommodate projected traffic volumes and enable free-flowing traffic to the greatest extent possible.

The DOT is required to follow federal requirements and procedures during its planning process. These federal requirements and procedures prescribe a planning process that:

1) is coordinated with county transportation officials, and 2) considers county general and transportation-related plans.

The DOT continues to satisfy both of these requirements. As a general practice, the DOT regularly consults with county transportation officials and consistently considers county general and transportation-related plans. By partnering actively and directly with the counties, the DOT has avoided or minimized conflicts with county plans. The DOT will continue this long-standing practice in all of its upcoming undertakings.

This bill's mandate that DOT comply with the various county plans, however, places an unrealistic burden on DOT's planning processes. Based on the foregoing reasons, we respectfully recommend that this bill be held in committee.


The Department of Transportation Services supports House Bill No. 865 that requires the Statewide Transportation Council to comply with the county transportation and general plans.
