Description: Certifies entities as exclusive representatives without an election where no other representatives are certified as the exclusive bargaining representatives. Requires immediate collective bargaining between parties once entities are certified as exclusive representatives. Effective July 1, 2020. (HB952 HD1)

My name is Charlene Cuaresma. I am submitting testimony in strong support of this bill with an amendment to not adopt HD 1. As president of the Filipino Coalition for Solidarity, I want to express appreciation to you for hearing this important bill. Since its inception in 1990, the Coalition has represented more than 50 Filipino community leaders, whose aim is to work for social justice issues to empower Filipinos to make socially responsible contributions to Hawai'i and our global neighbors through education, advocacy, and social action.

Filipinos and immigrant groups comprise a large segment of the hotel and agricultural labor force. Filipinos have also been hardest hit by unemployment, even before this recent downturn in the economy. As staunch supporters of Pacific Beach Hotel workers, our Coalition has learned from the workers themselves, that provisions of this bill are essential to safeguard a worker's right to determine union representation through the card check process. Card check is necessary, because some employers resort to tactics that create a climate of intimidation. We also disagree with the HD 1, which narrows this bill to apply only to companies with 100 or more employees, which amounts to about five companies, two of which already have representation by ILWU. We believe that this narrow definition amounts to "union busting". Therefore, we propose the amendment to delete HD 1.

There are many lessons learned from the Pacific Beach Hotel. For example, workers' attempts to unionize and negotiate a contract were thwarted by a "shell game" of changing owners and management that not only disregarded the workers' desire for union representation, but also dismissed progress made toward contract negotiations that were ultimately not recognized when "new" ownership ensued. This bill addresses this type of labor injustice, and affords workers the confidence to speak up to improve working conditions without fear of losing their job. I grew up with the insidious intimidation experienced by my father, a retiree of Oahu Sugar Plantation, and my grandparents, who were sakadas, or sugarcane contract laborers. With representation by the ILWU, the quality of life improved for the workers and their families. Card check is important because in spite of the use of voting by "secret ballot", intimidation from employers who are anti-union persist today.

Your consideration to support this bill is appreciated. Thank you for the opportunity to provide this written testimony.

HARC opposes HB 952 HD1, Relating to Labor, for the following reasons:

The measure is bad for business, especially small businesses, including agriculture. Unionization is not appropriate for all businesses and will cause some farming operations to give up the struggle. It will increase the cost of locally produced products at a time when all of us in Hawaii are grasping to find ways to lessen our dependence on mainland and foreign imports and become more self-sufficient.

The measure is also bad for Hawaii farm workers, who are some of the highest paid in the nation, in that it will strip them of their right to exercise their vote in private, opening the door to undue pressure and coercion, and forcing them to turn over a portion of their paycheck for union membership that is unnecessary and potentially detrimental.

H.B. 952, H.D. 1 – RELATING TO LABOR

The Hawaii Government Employees Association strongly supports the purpose and intent of H.B. 952, H.D. 1, which proposes amendments to Chapter 377, HRS (The Hawaii Employment Relations Act). The bill proposes streamlining union certification and facilitating initial collective bargaining in the private sector. The proposed process permits the employees, with a majority of their signatures, to petition to be represented by a union. Currently, an employer does not have to recognize the majority's signatures and can insist on a secret ballot election. The measure will help level the playing field, giving the choice to employees.

The other suggested additions to Chapter 377, HRS, will facilitate settlement of an initial collective bargaining agreement. The measure will prevent efforts by employers to stall negotiations indefinitely. The bill requires the parties to make every reasonable effort to reach an agreement; provides for a request for conciliation and, ultimately, arbitration to resolve a dispute; and provides for a collective bargaining agreement that will be binding for two years.

Labor unions have a significant role to play in helping our economic recovery and restoring the middle class. We strongly support the proposed legislation to streamline union certification and give employees a voice at work.

The General Contractors Association of Hawaii (GCA), an organization comprised of over five hundred and sixty (560) general contractors, subcontractors, and construction related firms, **opposes** the passage of H.B. 952, HD1, Relating to Labor.

The proposed bill allows and encourages labor organizers to pressure employees to sign up against their will.

We believe that if the majority of the employees favor organization then they will vote that way in a secret ballot. The right of self organization is thus preserved without taking away the right of those who wish to refrain.

The Bill as written is also very broad and would apply to every business large or small. It would apply to businesses with thousands of employees and also to every other small business in town with a handful of employees. It would also compel arbitration and a contract binding for two years if the business last that long. It is also unclear who will have to pay for an expensive binding arbitration to determine the contract terms.

This bill does away with the employees' right to a secret ballot and is tilted in favor of union certification.

The GCA opposes the passage of H.B. 952, HD1, and recommends that this bill not be passed.
