Aloha All, As a Retired Detective, NYCPD, I want to give some input as to what NYPD, has done and continues to do in the area of Arrest Warrant's.

- 1. Each Patrol Officer is given 10 Arrest Warrants of wanted persons in the area they are assigned.
- 2. Officer puts out the word in that area, that the person is wanted, and suggest to the residence of that area to convince the wanted person, to turn them selfs into Police.
- 3. Most times the Patrol Officers, know the wanted persons, but are not aware of the Arrest Warants exist.
- 4. As a Member of the Waikiki Neighborhood Board, I suggested the above to the Officers who attended our meeting 3 months ago.
- 5. HPD, now does post Photos of Wanted Persons on Local TV, and it does WORK. To that end the steps above also end with results. If the heat is turned up they do turn them selves in.
- 6. I have found that the best days to find them at home is on MOTHERS DAY, AND X-MAS, IF I HAD TO WORK THOSE DAYS OR NIGHTS,I would wind up in Court with people arrested on Warrants. Any Police Officer can tell you the best time is 6AM any day of the week.
