HCR 217, HD1 Requesting the University of Hawai'i Board of Regents to Develop Plans for a Scholarship Program for Hawai'i Residents to Study Abroad

Chair Tokuda, Vice Chair Sakamoto and Members of the Committee:

The University understands and values the importance of our students, in particular those who are Hawai'i residents, studying abroad as both ambassadors of the United States and the State of Hawai'i as well as recipients of a broader worldview in an increasingly globalized society. While the University supports the idea of encouraging resident students to study abroad, we instead would like to suggest that the resolution request the UH campus administrations with study abroad programs to study the feasibility of creating such a scholarship on their campuses, augmenting an existing scholarship for study abroad students, or exploring alternative avenues for funding.

The reasons for the request are:

- 1. While the resolution requests the University Board of Regents to develop a scholarship program for Hawai'i residents, all of the information in the resolution pertains only to the Manoa campus. Specifically, it reflects only information about Manoa students who study through the UH Manoa Study Abroad Center. In fact, UH Manoa students can also study abroad through various other mechanisms, such as through international exchanges, where students pay the UH tuition and then attend tuition-free at the international partner university. UH Manoa actually has 61 such options for students and is very cost-effective. Furthermore, the UH system offers study abroad options through Kapiolani Community College and Leeward Community College, both of which have very active study abroad communities.
- 2. Students who study abroad have access to some funds. They can retain their financial aid if they have financial need or augment their aid due to increased study abroad costs. They also have access to apply for several sources of funding, such as the national Gilman funds or national Freeman funds to study in Asia, Freeman or Honda funds (if UH community college students), and federal Foreign Language and Area Studies (FLASS) funds. UH Manoa students currently have access to some study abroad scholarships at UHM as well.
- 3. The UH Board of Regents has a comprehensive financial assistance program, created in 2006, which provides for an increase of financial aid and scholarships for students. The program in particular increases aid for Hawai'i resident students, in keeping with the University's mission and strategic goals. It also allows for campuses to develop their own scholarships based on financial need or merit/service, and certainly could allow for the creation or increase of study abroad scholarships, should it be a strategic priority for the campus.
- 4. Since the creation of a study abroad scholarship is not currently one of the UH Board of Regents approved priorities, we remain concerned about the cost implications generated by this proposal, in light of budget challenges and varying priorities.

Dear Senator Tokuda.

As both an administrator at the University of Hawaii and the father of a UH Manoa student who is currently in Japan via the UH Study Aborad Program, I would like to testify in behalf HCR 217. As you are no doubt aware, as unique and beautiful as Hawaii is, it affords its bright young minds with few opportunities to easily go to other places and see how other people live, eat, play and interact. I confess that I was a little dismayed when my daughter decided that she wanted to attend UH Mano, even though I think it is a great institution and I am an alumnus of its graduate programs. I had hoped that she would study on the mainland and be exposed to very different ways of life, climate, values and styles. My dismay was greatly attenuated when she told me that she would get this by going to Japan.

In truth, she has. She has now been there for over half a year and it had been the kind of experience that I wish every college student could have. The cost, I fear, is too prohibitive for many local families and many intelligent and eager young students do not even consider this due to the lack of financial support. It should go without saying that more scholarship money for this program would be of great benefit to such students and, in the long run, to the State of Hawaii, as these students will return with the kind of broad perspectives and understandings which daily grow more essential to the needs of our islands for leadership within a global marketplace.

I offer my strongest support to this bill and hope that you and your committee will have the vision to invest in this even while funds are harder to find. It is the best kind of investment for our future and anyone who values education will see the need for it.

I studied Shakespeare in his birthplace and took an art course that utilized the many and varied museums of London. In addition to taking courses, I was able to experience a different culture and see things from another perspective. The education I got on that UHM Study Abroad Center program went far beyond the classroom and really educated me for life.

I now have the privilege of advising UHM students who want to study abroad. For the vast majority of students that I advise, the primary factor standing in the way of them studying abroad is money. The UHM resident tuition is fairly low in comparison to the cost of attending school overseas on study abroad programs. We would like to be able to offer UHM residents scholarship monies to support their participation in UHM Study Abroad Center programs.

Dear Chair and Vice Chair:

My name is Sarita Rai. I am the Director or the University of Hawai`i Mānoa Study Abroad Center and a Windward Resident. I attended and received all my undergraduate and graduate degrees at UH Mānoa and am proud to work there and serve the State of Hawaii and its Community.

I support HR 217 because of its far reaching impact on the young residents and future leaders of the State of Hawai'i. I would like to quote the words of the retired Secretary General of the United Nations Kofi Anaan that succinctly encapsulates what the result of HR 217 will be and why.

"Clearly, we need to use education to advance tolerance and understanding. Perhaps more than ever, international understanding is essential to world peace -- understanding between faiths, between nations, between cultures. Today, we know that just as no nation is immune to conflict or suffering, no nation can defend itself alone. We need each other -- as friends, as allies, as partners -- in a struggle for common values and common needs."

To Study Abroad is to Dare to Discover, Dare to Learn, and Dare to Understand from others' perspectives while living away from one's own comfort zone.

The University of Hawai`i at Mānoa Study Abroad Programs enable students to earn credits toward their degrees without delaying graduation. Courses are offered in a wide range of fields in many countries, and fulfill foundations, focus, second language, certificate, minor, major, elective, or graduation requirements.

Even though, Hawai`i is a special place and my home, I became an adult here, have family, friends and supporters, I would have never known how to appreciate, contribute to, nor celebrate cultural differences of a society had I not studied abroad — not as a tourist for a few days - but truly lived among, and studied with citizens of other nations. Having lived and studied abroad made me understand, open my eyes and mind to both Hawai`i and the rest of the world. This type of understanding cannot be achieved only by taking "global" or "multicultural" courses offered on campus. Students will, however, have the desired learning outcomes of what it means to be "global" and "multicultural" through study abroad.

Therefore, I believe that young Hawai`i residents attending college must also Study Abroad before they graduate, as do most of their peers on the Mainland. Today we are not living in a society where our parents grew up, received their education, and then entered the workplace. It is our responsibility then, to ensure that our young residents are provided with the best opportunities that will enable them to succeed in the 21st Century. Studying Abroad gives them this edge.

It is clear to me that Hawai`i residents after studying abroad tend to work and live in Hawai`i. I know of this because many of the Study Abroad Alums are living and working in the State of Hawai`i as educated professionals who are productive, informed, and contributing members of this society. They are in the fields of Business, Education, Engineering, Science, Medicine, Nursing, and Law - to name a few.

However, the cost of studying abroad is of course higher than what one would pay if attending Mānoa only. HCR 217 would enable all Hawai`i resident students to Study Abroad easing the financial burden while helping to increase their comparative advantage among their peers.

Passing HCR 217 would be a powerful statement from the Hawai'i State Legislature in support of higher education as well as an understanding of what it means, and takes to educate young people in preparation for their life in the 21st Century.

Hence, I humbly request that you pass HCR 217. Thank you for you time and consideration.

I strongly support the resolution requesting the University of Hawaii Board of Regents develop a plan for a scholarship program for Hawaii residents to study abroad.

I've been a Professor in the Business School for over 38 years, and during this time I have observed many students who have gone on, and benefited from, a study abroad program experience.

When I talk to students about going on Study Abroad, I tell them that it will be a life changing event, they will never be the same, and most likely it will be for the better.

We are very fortunate to have a strong Study Abroad program an office. It provides good quality experiences for students in well run and overseen programs. It's existence is one of Manoa's gems

One of the better support programs for students studying abroad is the Oscar and Rosetta Fish Scholars program in the Shidler College of Business. The Fishes established a fund for Shidler students and part of the funds are used for a travel abroad experience, and some of the Fish Scholars use it for study abroad.

I've seen the good the Fish Scholars program does, and it is a limited but good step in the right direction. If I was at the UH Foundation I would love to have a UH Study Abroad Scholars program to raise funds with. It would be such an attractive way to attract scholarship funds that I find it surprising it hasn't been done already.

When I talk to students about going on a study abroad program cost is usually one of the first topics to come up. I explain that that cost they need to consider most is the marginal cost, what it will cost to be on study abroad. They will need to eat, have housing, and probably school expenses if they stay at UH. It that costs them lets say \$9,000, and study abroad costs \$14,000, then the marginal cost is the extra \$5,000. This makes it seem lower, but it doesn't overcome the fact that it does cost more to go.

The gain to a student from a study abroad experience is large. It's disappointing when the expense stops a student wanting to go from having this opportunity.

This resolution asks the University to plan for a scholarship program that specifically targets going on study abroad and I think this would be a very good idea. It shouldn't take a resolution to advance this idea, but having a resolution should certainly get things moving.

To the members of the Committee

Since the 1990s, I have been teaching a variety of courses in political science, Asian and research design on three campuses of the University of Hawai'i System. Meanwhile, the focus of my publications and conference presentations has been in comparative politics, Asian studies and international studies.

As a tax payer and registered voter, I am writing to express my strong support for House Concurrent Resolution 271. <u>The University of Hawai'i Board of Regents should be urged to develop a scholarship program for Hawai'i residents to study abroad</u>.

For about twenty years, the UH Study Abroad Center has been a model -- a leader -- among colleges and universities that understand the value of providing their students the option to deepen their international education by studying one or two semesters in another country and in a different culture.

UH Study Abroad Center courses are reviewed and vetted by a special faculty board. Students and faculty receive tailored orientations. And the Director of the Study Abroad Center routinely makes site visits to campuses where UH Study Abroad students are engaged. UH students studying abroad under the aegis of the Study Abroad Center typically are part of a cohort of UH students under the supervision of a selected UH faculty resident director. And conveniently, the student directly earns UH credits.

In my personal experience as a teacher, students returning from having studied one or two semesters in another country under the Study Abroad Center program routinely demonstrate heightened interest and insight in Asian studies, political science and research design courses. Not only are these students usually more interested in learning more, these students tend to be noticeably adept interacting with their classmates and at understanding the nuances of perspectives different from their own. These are important social and cognitive skills for future UH alums.

Among other current threats to the quality of a UH education, the cost of this education is slipping beyond the reach of many local students. Increasingly, a study abroad experience is an essential part of that education. Therefore, HCR 217 deserves your careful attention and your active support.

If Higher Education Committee staff need more detailed information or testimony about the value of a study abroad learning experience under the direction of the UH

Study Abroad Center, they may feel to e-mail me this week.

Mahalo for considering my views on this topic of importance for the quality of education received by undergraduate students at the University of Hawai'i.

Dear Senator Jill Tokuda,

For the past 26 years, our Asian Field Studies Program have taken undergraduate and graduate UH students on 2-3 week tour of businesses throughout Asia. Last year, we took 25 students on a three-week tour of businesses in Tokyo, Shanghai, Delhi, Bangalore, and Hanoi, visiting such firms as Dentsu Advertising, President Brenda Foster at the American Chamber of Commerce in Shanghai, Cisco's Globalization Center in Bangalore, and Vietnam Post and Telecom. Most student evaluations comment that this is single most impactful program they have taken at the UH. More information on the program is available at shidler.hawaii.edu/asianfieldstudy and shidler.hawaii.edu/pami.

As commented by one of our past students, "If you want to learn international business you can read a book. To experience it takes you to new levels of understanding that cannot be compared to anything you would find in a book." This student is currently the appointed head of a major state agency and has put his international experience to direct use.

Through Federal DOE Title VI funding, our department provides scholarships to other study abroad programs. We receive similar comments sprinkled with heartwarming stories that have changed students' lives and broadened their way of thinking. It is one of our most impactful and rewarding programs with immediate measurable educational benefit.

This year, our enrollment in the Asian Field Studies program dropped from an average of 20 students to a handful, much due to the tough economic times and students' inability to afford the incremental costs of education. Most of our counterparts at the big name business schools send ALL their students on a mandatory international experience, due to their funding from large corporations and foundations, something we lack in Hawaii due to scale. I find it disheartening that our students, particular our kama'aina, remain insular despite prime location being in the middle of the Asia Pacific region.

I strongly urge the Senate to provide funding for scholarships to our Hawaii residents in order for them to be given the same opportunity as students at better funded universities. While it will be difficult to measure short term economic gain, this is an essential educational experience to develop Hawaii's human capital for long term economic gain, particularly in the development of the export services industries. International exposure will provide our students and our future leaders of tomorrow greater potential to think outside the bounds of Hawaii and realize their full potential growing up in an Asia Pacific culture.

Dear Senator Tokuda,

I would like to offer my wholehearted support of HCR217. After graduating McKinley High School, I never really had the desire to leave Hawai'i to attend college on the Mainland. When I was attending UH-Mānoa and heard about study abroad programs, I was fortunate enough to be able to apply for and participate in four different programs over the course of five years. While my time spent abroad proved valuable personally and professionally, without the financial support of my parents, I would not have been afforded the opportunities. Other students may not be so lucky.

My study abroad experience had a direct impact on my career. Upon completion of my masters degree, I became an advisor with the Study Abroad Center at UH-Mānoa, a position I have had for over 11 years. When advising prospective students, I come across many who would benefit greatly from a study abroad program as I did, but are reluctant to follow through because of lack of money. With a scholarship specifically for Hawai'i students for study abroad programs, such students can realize their potential and perhaps give back to Hawai'i one day as I am doing.
