Chair Souki, Vice Chair Awana and Members of the Committee:

Thank you for the opportunity to provide comments on H.C.R. No. 228 / H.R. No. 197. The Agribusiness Development Corporation (ADC) completed a study by contract titled "The Demand for Interisland Shipping and The Impact of Shipping Costs on Hawaii Agricultural Production" which revealed that less-than-container-load (LCL) shipping is important to meet local agribusiness and food manufacturer's needs. In addition, it concluded that discontinuation of LCL shipping would have a significantly negative financial impact on many of these businesses.

The ADC believes that Young Brothers (YB) has shown willingness to work with the State to allow time for problem-solving by entering into a Memorandum of Understanding which extends the timeline for continuation of LCL service. It is also our understanding that at this present time and in the foreseeable future YB does not have any plans to discontinue LCL service.

DESCRIPTION:

These resolutions urge the Hawaii Public Utilities Commission ("Commission") to not allow Young Brothers, Limited ("Young Brothers"), a water carrier providing intrastate shipping services, to discontinue its less-than-container-load ("LCL") services to and from Maui, Molokai, and Lanai.

POSITION:

The Division of Consumer Advocacy ("Consumer Advocate") offers comments for this Committee's consideration.


COMMENTS:

The resolutions state, among other things, that: (1) Young Brothers petitioned the Commission for approval to eliminate LCL interisland cargo service to and from Maui, Molokai, and Lanai and that current customers of Young Brothers on those islands have expressed grave concerns about the effects of Young Brothers' plans on their economic future if LCL service is discontinued.

Young Brothers has not, as the resolutions state, petitioned to eliminate LCL service. Instead, Young Brothers requested approval to change its sailing schedule, which is being considered by the Commission at present. In fact, the Commission is traveling this week to Maui, Molokai, and Lanai to take public comment on the proposed sailing changes. After consideration of such public comment, the Consumer Advocate will provide the Commission with a written position statement for its consideration.

> Testimony of Roy Catalani, Vice President of Strategic Planning and Government Affairs, Young Brothers, Limited

Chair Souki, Vice Chair Awana, and Members of the House Transportation Committee:

Thank you for the opportunity to testify on House Concurrent Resolution No.228 and its companion, House Resolution No. 197 ("HCR 228/HR 197" or, collectively, the "resolutions").

Young Brothers, Limited (Young Brothers or YB) offers comments on HCR 228/HR 197.

The resolutions urge the Public Utilities Commission ("PUC") to "not allow Young Brothers, Ltd., to discontinue less-than-container-load shipping to and from Maui, Molokai, and Lanai" and cite a YB petition filed with the PUC for approval to eliminate such service, commonly referred to as "LCL service".

In short, HCR 228/HR 197 are unnecessary. There is no YB petition to discontinue LCL service to and from *any* of the islands served by Young Brothers. And the issue of LCL service discontinuance is not before the PUC in any of the YB applications now before the PUC.

As YB has done in the past, we will continue to work and dialogue with shippers of LCL cargo, such as farmers and small businesses, to discuss concerns and issues. We invite legislators, as well, to engage in a dialogue with Young Brothers about its services, including the transport of LCL cargo.
