TESTIMONY IN OPPOSITION TO HCR 281

Housing Committee April 1, 2009 9:00 a.m. Room 325

The Legal Aid Society of Hawaii hereby provides testimony in opposition to HCR 281.

Legal Aid provides free legal services to the low-income population of the State of Hawai'i. In additional to providing services to clients who currently reside in public housing, we also assist individuals who are on the waiting list to gain access to public housing.

The current guidelines give preference to the neediest of our population: victims of domestic violence and the homeless. These are the people who need entry into public housing the quickest. Failure to provide preferences for emergency situations will defeat the purpose of this resolution: to provide public housing to those in need. Elimination of the preference for victims of domestic violence will result in more women being unable to leave dangerous situations.

Rather than do away with the homeless preference altogether, I would suggest changes be made to the current systems. One of the simplest and most efficient ways to do this is to re-define homelessness.

I would suggest that it would be more effective for the committee to resolve:

WHEREAS various problems have been encountered due to the current definition of homelessness, be it resolved that:

A homeless family is defined as a family who has lived in a homeless or a transitional shelter for the maximum time period allowed, or for one year, whichever is greater;

A homeless family is defined as a family who has lived with friends or relatives in conditions with more than two persons per bedroom, for one year;

A victim of domestic violence is defined as a person who has a current Protective Order issued by a state or federal court;

Thirty percent of public housing vacancies will be filled by families who are currently on the waiting list, beginning with those who have been on the list the longest;



Changes to the preference definition would optimize the housing that is available, without abandoning the truly homeless to life on the beach, in the parks and on the streets.
