HOUSE CONCURRENT RESOLUTION NO. 303 SUPPORT FOR PEACE CORPS EXPANSION ACT OF 2009

Chairperson English and Members of the Committee:

My name is Duane Okamoto and I am the Deputy Director of the Hawaii Department of Agriculture. I am testifying in a personal capacity in strong support of HCR 303, which calls for an expansion of the Peace Corps through the Peace Corps Expansion Act of 2009.

I am testifying largely because I just received an email from a doctor friend now in Malawi who is spending his vacation at the only teaching hospital in the country. He has gone to Malawi at his own expense on his own time to offer his services because of having been a Peace Corps volunteer almost 40 years ago. I thought the least I could do would be to spend a little bit of time writing in support of a program that almost 50 years since its inception continues to motivate people to volunteer.

I was a Peace Corps Volunteer (PCV) in Ghana, West Africa. I believe that the Peace Corps is one of the finest and most appreciated of federal government programs and has done much to alleviate poverty, disease, and ignorance around the world.

All you have to do to verify this statement is go to the East West Center or any gathering of foreign students on college campuses and inevitably you will find someone who is there because a PCV helped to build a road so a village could sell its goods and afford a school, or they will know a PCV who taught them English so they could take an exam that led to a scholarship, that brought them to the US, or they will know a PCV who got them excited about science, or dug a well and brought clean water to their village.

Peace Corps is not a one way street with only foreign countries benefiting. The Peace Corps has given close to 200,000 Americans insights into cultures and ways of doing things that have enriched our communities when the volunteers have come home. They offer a fact-based perspective that balances the frequently negative stereotypes that are often perpetuated in the media about people in the developing world.

Hawaii has had a long relationship with the Peace Corps, having served as a training site for volunteers going to tropical countries and sending over 1,200 of its residents throughout the world. This year, Hawaii led the nation in the rate of increase in

volunteers. This only seems fitting given the diversity of our population and the ease in which we enter into social and professional relationships with people of different races and cultures.

At a time when the world is in economic turmoil, the developing countries of the world are being especially impacted. It is in America's best interest to increase our assistance to the developing world and an expanded Peace Corps is one of the best means for America to demonstrate our commitment to living together in Peace.

More detailed rationale has been presented. But my personal testimony argues in favor of the expansion of the Peace Corps at a critical time.

Our new US leaders have re-opened POLITICAL ties with many countries that have, in recent years, come to distrust our country. When the Peace Corps started under President Kennedy's term there was similar increased admiration for the USA. After political leaders left it was the common citizen COMMUNITY and SOCIAL ACTION of Peace Corps Volunteers that helped build bridges between countries and peoples. Since 1961 nearly 200,000 Americans have served in the Peace Corps. Early in its existence the Peace Corps became a model for other countries to organize volunteer efforts of their own citizens abroad.

I can easily say serving as a math and science teacher in Northern Malaya as a Peace Corps Volunteer gave me my perspective of appreciation for LEARNING from other cultures and SHARING our culture. I came to view our own culture from a different perspective that, at times, seems to counter the materialistic life styles of people who haven't experienced living and working overseas.

When I arrived in Hawaii in 1965 my first job was serving on the staff of the Peace Corps Training Centers in Hilo and Molokai. I was part of the original group of Returned Peace Corps Volunteers who started the Hawaii RPCV group that continues to this day and now joins me in urging passage of this legislation. To meet the President's stated goal of 16,000 volunteers in the Peace Corps we must pass the Peace Corps Expansion Act 2009. Please help that goal become a reality by passing this legislation.
