Chair Hanohano and members of the Committee, the Drug Policy Action Group strongly supports this resolution which requests state and local law enforcement officers to abide by state laws regarding medical use of marijuana.

This is a resolution which by all rights should not be necessary. The state's law permitting the medical use of cannabis has been in place since 2000. Yet there are still law enforcement officers at state and local level who do not abide by either the letter or spirit of the law. This may be because they disagree with the law, as has been explicitly stated for example by Maui county Police Chief Phillips. Nonetheless, these officers are sworn to uphold the law - even if they do not agree with it.

There have been many instances of raids on registered patients where their supplies of permitted amounts of medical marijuana have been seized.

This body saw fit to pass this compassionate law nine years ago. The time is past due when law enforcement officials should accept this fact and adhere to the law of the land.

We urge this committee to pas this resolution out preferably with stronger language. Mahalo for the opportunity to testify.
