> Testimony of Nestor Garcia, President, Hawaii State Association of Counties Senate Bill 101, SD 1 Regular Session 2009

Chair McKelvey and members of the Committee:

Thank for you this opportunity to offer comments on SB 101, SD1.

At the request of a member of the Taxi Industry two years ago, I introduced legislation at the Honolulu City Council that sought to address the need for various security measures for the safety of the driver and their passengers. Included in the bill were measures to cover the installation of security devices, revocation of licenses, and criminal background checks of drivers and driver applicants.

Following a thorough legal review by the Office of Council Services and the City Corporation Counsel, the Council Transportation & Public Works Committee considered the matter at its February 7, 2008 committee meeting. The resulting legislation narrowed the focus to the need for criminal background checks of taxi drivers and taxi driver applicants.

Issues and concerns expressed in committee included the legality of permanently denying and/or revoking a taxicab driver's certificate and whether the City had the authority to conduct FBI background checks on drivers. It is unclear whether the City currently has the authority to access the FBI's database for this purpose. And while the State maintains a database to conduct local criminal background checks, persons who are convicted of out-ofstate, federal or international crimes would not be included in the database. Senate Bill 101 seeks to address these concerns and determine the appropriateness of enabling the counties to conduct criminal background checks on taxi drivers and taxi driver applicants.

Thank you for the opportunity to look into this matter. We look forward to the discussion and deliberation to come.
