RE: Senate Bill 269; MAKING AN APPROPRIATION FOR A PHYSICIAN ASSISTANT PROGRAM

Thank you for the opportunity to write testimony IN STRONG SUPPORT of this bill and its intention to establish a PA training program within the John A. Burns School of Medicine. I only wish I could be there personally to applaud this effort.

Such a program is long overdue in Hawaii. Physician Assistants, working with physicians as clinical supervisors, have the potential to make an enormous contribution to health service delivery in Hawaii; to the rural and underserved areas, in operating theaters and emergency departments, and anywhere else a physician or a clinic might utilize them.

Candidates for this program will come from an eager bunch of alumni of Hawaii's Community College system; EMTs, Lab Technicians, Respiratory Therapists, and the like, all looking for a way up the clinical ladder to become "clinical practitioners of medicine". Only nurses can become Advanced Practice Nurses (APRNs), leaving all these other health professions with no route to get to this level. Such a program will afford them a way.

PAs have been present in Hawaii since the early 1970s, yet their numbers are nearly static. Hawaii ranks 45th nationally in the per capita utilization of PAs. The Physician/PA model of delivering high quality, cost effective services has been well documented over the last four decades in every venue nationally and now internationally. Why not in Hawaii? Perhaps our health care crisis has finally pushed us to recognize the value of this under utilized cadre of health professionals.
