The Hawai'i Tourism Authority (HTA) supports S.B. 271, S.D. 2 which adds a national and/or global economic crisis to situations considered a tourism emergency.

The current law identifies a world conflict, terrorist threat, natural disaster, outbreak of disease, or other catastrophic events as a tourism emergency but is not clear that the Tourism Emergency Trust Fund could be used to respond to a national or global economic crisis such as the one we are in currently. The economic crisis is resulting in a substantial interruption of commerce and adversely affecting the welfare of the people of Hawai'i, but is not caused by the events described in the current law.

We also supported H.B. 960, which added regional or world-wide crisis, and may allow a response to a situation that may not be national but affects a region.

Chair Manahan, Vice Chair Tokioka and Members of the House Committee on Tourism, Culture and International Affairs.

The Department of Business, Economic Development and Tourism supports SB 271 SD2, which would amend Section 201B-9 (a), Hawaii Revised Statutes, by adding a "national or global economic crisis" to situations considered when declaring a tourism emergency.

We strongly believe that the current world economic crisis has had the same effect that a world conflict, terrorist threat, natural disaster or outbreak of disease would have on Hawai'i's tourism industry and the state's economy. Therefore, allowing access to the tourism emergency fund for this reason is justifiable.

Once the tourism board asks the governor to declare a tourism emergency, the authority shall develop and implement measures to respond to the emergency. While we appreciate the specification of this bill that no action may be taken by the authority without the governor's express approval as it relates to a national or global economic crisis, we do not believe that this language is needed since the governor, in theory, has already given approval by declaring the emergency.

Good morning Chairman Manahan and members of the House Committee on Tourism, Culture and International Affairs. I am Murray Towill, President of the Hawai'i Hotel & Lodging Association.

The Hawai'i Hotel & Lodging Association is a statewide association of hotels, condominiums, timeshare companies, management firms, suppliers, and other related firms and individuals. Our membership includes over 170 hotels representing over 47,300 rooms. Our hotel members range from the 2,523 rooms of the Hilton Hawaiian Village to the 4 rooms of the Bougainvillea Bed & Breakfast on the Big Island.

The Hawai'i Hotel & Lodging Association supports SB 271 SD2 Relating to Tourism Emergency. This bill would clarify that the Tourism Emergency Trust Fund could be utilized for an economic disaster as well as a natural or terrorist created disaster as indicated in the current statute. Our experiences over the last year clearly indicate the value of this step.

The US and Hawaii are currently facing the most severe economic times since the Great Depression of the 1930s. Unfortunately, the current law does not appear to allow the HTA to access the \$5 million in this Fund. Some of the funds could greatly aid Hawaii's effort to attract visitors and keep our people working right now.

RMH supports SB271, SD2, which adds a national or global economic crisis to situations considered a tourism emergency.
