The Department of Public Safety supports Senate Bill No. 309, to clarify that the Sheriff Chaplains are entitled to workers' compensation.

This bill is needed to amend the Hawaii Revised Statutes section 386-181 to include the Sheriffs' Chaplain. The Sheriffs' Chaplain should receive the same Workers' Compensation benefits as other volunteers indicated in the subject law whereby the Sheriffs' Chaplain provides similar services as the Police Chaplain.

Chair Oshiro, Vice Chair Lee and Members of the Committee:

My name is Jim Tollefson and I am the President and CEO of The Chamber of Commerce of Hawaii ("The Chamber"). The Chamber has a proposed amendment to SB 309 relating to Workers' Compensation.

The Chamber respectfully asks that the committee amend the measure by adding language from HB 602.

Workers' compensation provides medical insurance and wage loss for work related injuries for employees while protecting employers from civil liability resulting from such injuries. The Chamber believes that this measure is consistent with the intent of protecting employees while helping employers reduce overhead costs by enabling businesses to save on workers' compensation premiums.

The Chamber is the largest business organization in Hawaii, representing more than 1,100 businesses. Approximately 80% of our members are small businesses with less than 20 employees. As the "Voice of Business" in Hawaii, the organization works on behalf of its members, which employ more than 200,000 individuals, to improve the state's economic climate and to foster positive action on issues of common concern.
