

### RELATING TO ANIMALS.

Prohibits, with exceptions, the practice of tethering dogs.

### Mr. Chairman and Members of the Committee:

Thank you for the opportunity to present my testimony, supporting this legislation.

Below are 5 reasons why we need to ban chaining of dogs by owners,

### 1) Chaining dogs makes them more aggressive

Boxers are not known as ferocious fighting dogs. The Website www.boxer-dog.org describes the breed as "energetic, playful, loyal, family-oriented."

Ashley Evans, 2, has evidence to the contrary all over her body.

The toddler was in her aunt's yard in the 3400 block of Ohio in Dickinson, when she wandered toward her aunt's dog, chained to a tree.

The dog mauled the child and later charged a police officer, who shot the animal. County Animal Control officers later euthanized the dog.

The problem was not the dog's breed, but its confinement, experts say. Animal experts and handlers say dogs chained to fixed objects and left unattended often became aggressive and territorial.

Chained dogs typically lack adequate veterinary care, food, water or shelter, and are often deprived of exercise and interaction with their families.

Chained dogs often spend little time around people and other animals, stunting the dogs' social development. Also, dogs are territorial by nature, and when their territory shrinks to the circumference of a chain, they defend their areas fiercely.

# 2) Dog fighters do not like anti tethering laws.

90% of the time, fighting dog breeders are against anti-tethering laws, because it would make their job harder. Dogs bred and trained for fighting (mostly pit bulls) would kill one another if they were housed together.

Since kenneling dogs individually is costly, most breeders simply separate fighting dogs by tethering them with heavy chains to the ground or a stationary object. Banning or regulating chaining practices would take a huge bite out of the blood sport of dog fighting.

3) Having new rules on the books will give county animal control officers additional tools to protect both dogs and human life

In Galveston, TX, 90 percent of calls handled concerning aggressive dogs, involve chained animals.

Kim Schoolcraft, director of the Galveston, TX County Animal Control division of the health district, said a dog's nature was to be part of a pack or family.

"When a dog is isolated every day, for extended periods, it's going to take a psychic toll, just like it would on a human being," Schoolcraft said.

Galveston County's animal shelter, is one of many shelters in the county, that requires dog adopters to sign a contract saying they will not chain the dogs.

- 4) Children raised in a home, where dogs are chained and penned, are being psychologically and emotionally abused, living in an environment where moral standards (and the essence of humanity) are lacking. Children, in those situations, who love animals, are unquestionably being subjected to "parent abuse".
- 5) When a dog is chained or penned, what purpose can it serve if a perpetrator targets that home?

# Conclusion:

Mr. Chairman and valued members of the committee, when it comes to preventing animal abuse, there is no single magic bullet. Our goal is to slow the number of animal abuse cases, and improve the quality of life, not only of innocent helpless animals, but the humans who live and interact with them. This task won't be easy, and it won't be possible at all, without your continued support for this effort.

Testimony for Hawaii Dog Foundation regarding Measure SB 30 - Prohibits, with exceptions, the practice of tethering dogs.

We, the members of Hawaii Dog Foundation, support measure SB 30. Hawaii Dog Foundation is a non-profit organization that rescues homeless dogs, including abandoned and neglected dogs, and finds new homes for them. Hawaii Dog Foundation's mission is also to promote responsible dog ownership.

We have personally and extensively witnessed the psychological and physical damage that a dog experiences when tethered for long periods of time. Below are just a few of the reasons that we consider tethering inhumane (taken from the HDF Humane Education website):

- \* A tether significantly restricts a dog's movement, therefore causing frustration and boredom. Dogs are social animals; they need interaction with humans and other animals to survive.
- \* A tether can become tangled around a dog's neck or body and potentially cause injury or death. Dogs on chains or tethers frequently tug and pull against their restraints; this can cause their necks to be rubbed raw underneath their collars.
- \* Evidence has shown that dogs that started out friendly and well-behaved became unhappy, anxious, or even aggressive when they were kept on a chain.
- \* Tethered dogs often have no shelter from the elements. A dog that lives on a chain has no place to retreat from extreme weather conditions -- like the intense heat of many Hawaiian days.
- \* Dogs are usually not chained in a comfortable environment. The dog is forced to eat, sleep, urinate, and defecate all in the same confined space.
