Hawaii Medical Association (HMA) strongly opposes SB 420 because the bill will allow a naturopathic practitioner to administer a substance intravenously, or through injections. This should not be allowed unless the naturopathic practitioner is under the direct supervision of a physician.

A traditional naturopath will generally avoid procedures common to medical care such as: diagnosing disease, treating disease, prescribing drugs and pharmaceuticals, and performing invasive procedures. In determining the root cause of a client's problems, traditional naturopaths can not diagnose or treat disease, but instead focus on health and education. They teach clients how to create an internal and an external environment that is conducive to good health, enabling the clients to make their own choices. Traditional naturopathy is not a medical practice. Major and minor surgery, prescribing drugs and pharmaceuticals, giving injections and drawing blood should be limited to medical doctors only and not performed within the scope of naturopathy.

Most over-the-counter products (OTC) are not available for injection. There are no existing quality standards for the preparation of the materials that would be allowed for naturopathy injection and there is no evidence of any benefits.

Passage of this legislation would allow naturopaths to inject substances that are of variable strength and quality by a variety of routes into the human body. There is no requirement for manufacturers to assure that a quality standard is met in the production of these substances.
