

#### Dear Senators:

I am testifying in SUPPORT of SB 488 & SB 1188 which will make it illegal and a criminal act to leave dogs permanently tethered or chained as the loopholes in our laws currently allow. I feel this is one of the most important issues on animal cruelty that we can do to protect our pets because it addresses a situation that is happening right here, right now, 24 hours a day, 365 days a year to thousands of dogs across our islands.




#### Why I support SB 488 & SB 1188:

- Dogs are loyal, sociable creatures. It is inhumane to keep them permanently chained/tethered to a stationary object away from the main family as some kind of lawn ornament or cheap burglar system.
- It is especially inexcusable when the dogs, both large and small, are indiscriminately tethered to one spot despite being inside a fenced yard like I often see around the island.
- As they move around, their chains tend to get entwined around the pole they are tied to and become shorter and shorter until eventually, the dogs are forced to eat, sleep, and defecate all in the same spot of just 1-2 feet.
- In some allowable exceptions like in the case of unfenced yards or for exercise, I ask that amendments be made to allow for a TROLLEY/HARNESS system where the dog can have more freedom of movement. This system is inexpensive to set up (\$30) and can be purchased at most local hardware stores. (<a href="http://www.unchainyourdog.org/Trolley.htm">http://www.unchainyourdog.org/Trolley.htm</a>)
- When left permanently tethered outside, they are also usually deemed as easily replaceable, dispensable objects by their owners and are thus often neglected and denied basic comfort, medical care, and socialization.


- Nine out of ten, the dogs showed clear signs of terrible wear & physical degradation from being exposed to the elements at all time yet the owners are not fined/charged in any way for such obvious neglect and abuse.
- And finally, national statistics gathered by Dogs Deserve Better show that they are 2.5 times more likely to bite. From 2003 to 2007, at least 115 children in the US were killed or seriously injured by chained dogs. In Hawaii, the past 2 weeks alone has seen 4 incidents involving dog bites.
- It becomes doubly tragic when the dogs are then fatally punished as they get turned over to the Humane Society and inevitably put down.

### In Support of SB 488

I was raised in Niu Valley where I still live. Several years ago I had an experience with tethered dogs when new neighbors moved in. Unfortunately, these neighbors were burglarized during their first week. At about the same time, a newsletter was sent from the Niu Valley Neighborhood Security Watch that contained information telling of a reformed burglar who admitted choosing which house to enter by whether or not they had a dog.

The next weekend our new neighbors arrived home from the Hawaiian Humane Society with two large adult dogs in tow. They first put the dogs in their spacious, fenced back yard, but the dogs escaped by climbing over the 4 foot fence. As a solution, the neighbors tied the dogs around a single tree in the back yard on two short ropes.

I assumed that this was a temporary situation, until the neighbors could better secure their back yard. However, days turned into weeks and weeks into months. The only change that was made, after being confronted by a Hawaiian Humane Society officer, was to move the dogs to separate trees. This stopped the tangling, but now the dogs had no interaction with each other and after a few days they were sleeping most of the time and appeared depressed.

After one year of tethering, one dog was found dead in the yard, still tied to his tree and the other dog was taken back to the Hawaiian Humane Society and replaced with a burglar alarm.

The year I witnessed those two suffering dogs was a difficult one. I felt totally helpless to improve the situation, and at one point, I even asked to take over their care.

I learned in my many conversations with these neighbors that they believed that dogs only needed food, water and shelter. They were unaware of the psychological needs of dogs such as socialization and exercise. Laws teach people right from wrong. It is time for Hawaii to stop the cruel practice of inhumane tethering.

Dear Senators:

I am in support of SB488.

Dogs should not have to live at the end of a rope any more than you or I should. Tethering dogs full time is cruel because, like humans, they are social beings. Isolating a dog at the end of a rope deprives it of the basic need to interact with its "Pack." Dogs who do not get enough exercise or socialization are more frustrated and frustrated dogs are more aggressive.

There is overwhelming evidence that shows a chained dog is more likely to an unprovoked attack than an unchained dog would be. Therefore, to keep our neighborhoods safe, an anti tethering bill makes more sense, is more effective and more humane than a bill banning specific breeds such as pit bulls.
