Chair Takumi, Chair Rhoads and Members of the Committees:

The Hawaii State Teachers Association (HSTA) opposes SB 497 SD 1 in its current form, which establishes an advisory committee to provide oversight of the Hawaii Teacher Standards Board (HTSB) and provides the governor with lists of nominees for appointment to the board.

The HTSB's main purpose is to establish and maintain licensing standards for teacher licensing in Hawaii, issue and renew licenses, and revoke licenses when necessary.

HSTA has several concerns and questions related to SB 497, SD 1 which is as follows:

- First and foremost, the Hawaii Teacher Standards Board is an independent board on which the teaching profession is represented. Adding an advisory committee as an oversight body violates the concept. Creating such an oversight body would mean that the board is no longer independent.
- An advisory committee adds to an already burdensome bureaucracy. Now the HTSB will have to be concerned with the advice of an advisory committee besides other concerns as listed above.
- Who will bear the cost of the committee? Will teachers be asked to bear the cost through paying a higher fee to be licensed?
- We question the fact that if the HTSB is a teacher licensing entity, then why are teachers not represented on the advisory committee by the exclusive teacher bargaining agent. The Association is called upon by a teacher for assistance when the HTSB is not responsive and therefore, we are aware of the areas of concerns. In this regard, The Association can be the most effective in advising the board.

What is of greater concern to teachers is the Legislative Auditor Report, which says that HTSB exceeded its authority to extend licenses beyond those granted by statute to licenses expiring in 2002 and 2003. The teachers whose licenses were extended met all the requirements imposed by the board. HSTA believes that these teachers should not be penalized because of the actions by the board or the board's failure to act. As a result of this, our priority now is to ensure that the extended licenses are valid. We suggest this measure be amended to ensure that the licenses of thousands of teachers remain valid.

HSTA would therefore recommend amending section 302A-805, using language included in SB 1308 SD 1. The suggested amendments would read as follows:

"§302A-805 Teachers; license required; renewals. (a) Beginning July 1, [2002,] 2010, all new and renewal licenses shall be issued by the board. No person shall serve as a half-time or full-time teacher in a public school without first having obtained a license from the board under this subpart. All licenses issued by the board shall be valid only for the fields specified on the licenses and shall be renewable every five years if the individual continues to:

- (1) Satisfy the board's licensing standards;
- (2) Show evidence of successful teaching in the previous five years; and
- (3) Satisfy the board's requirements for renewal of licenses.
- (b) Teachers whose licenses expire on June 30, 2002, or June 30, 2003, shall be granted an automatic extension of [two] seven years.
- (c) No person shall be issued a license or teach on an emergency basis in the public schools without having first paid the fees established by the board in accordance with chapter 91.
 - (d) Teachers whose licenses expire on or after July 1, 2009, but before July 1, 2010, shall be granted an automatic extension of one year in which to obtain a renewal of their licenses.

 The board, at its discretion, may grant an additional one year extension of these licenses."

In summary, we urge this committee to (1) eliminate the establishment of an advisory committee and (2) pass legislation to validate extended licenses.

Chairman Takumi, Chairman Rhoads and Members of the Committees:

The Hawaii Teacher Standards Board does not support the creation of an advisory committee. We believe such a committee would be a duplication of effort and at a time when departments and agencies are facing drastic budget cuts, we can ill afford directing new resources to one more level of decision-makers.

The Board does, however, support the addition of a couple of new stakeholder groups to become members of the Board while also maintaining a reasonable number of members so that the Board's work remains manageable. To this end, we recommend the following amendments to SB 497 SD1:

- 1. Delete Sections 2, 3, and 4 of the bill.
- 2. Insert the following new Section 2 to replace the deleted sections above:

SECTION 2. Chapter 302A-801, Hawaii Revised Statutes, is amended to read as follows:

§302A-801 Hawaii teacher standards board established. (a) There is established the Hawaii teacher standards board, which shall be placed within the department for administrative purposes only. The board shall consist of [thirteen] fifteen members, including not less than six licensed teachers regularly engaged in teaching, three educational officers, the chairperson of the board of education or the chairperson's designee, the superintendent of education or the superintendent's designee, a representative of the independent schools, [and] the dean of the University of Hawaii college of education or the dean's designee; provided that the dean's designee shall be chosen from the member institutions of the teacher education coordinating committee established under section 304A-

- 1202. Two additional members shall be appointed from among the following: 1) Hawaii Business Roundtable; 2) Hawaii P-20 Council; or 3) Workforce Development Council.
- (b) Except for the chairperson of the board of education, the superintendent, and the dean of the college of education, the governor shall appoint the members of the board pursuant to section 26-34, from a list of qualified nominees submitted to the governor by the departments, agencies, and organizations representative of the constituencies of the board. To the extent possible, the board membership shall reflect representation of elementary and secondary school personnel from all islands.
- (c) Appointed board members shall serve not more than three consecutive three-year terms[; provided that the initial terms of the appointed members that commence after June 30, 2000, shall be staggered as follows:
 - (1) Three members to serve three-year terms;
 - (2) Three members to serve two-year terms; and
 - (3) One member to serve a one-year term].
- (d) Board members shall receive no compensation. When board duties require that a board member take leave of the board member's duties as a state employee, the appropriate state department shall allow the board member to be placed on administrative leave with pay and shall provide substitutes, when necessary, to perform that board member's duties. Board members shall be reimbursed for necessary travel expenses incurred in the conduct of official board business.
- (e) The chairperson of the board shall be designated by the members of the board.
- 3. Renumber Section 5 of the bill to become Section 3.
- 4. Amend Item (d) in Section 5 (new Section 3) as follows:
 - (d) The board may employ an executive director, exempt from chapters 76 and 78 who shall be appointed by the board [of education pursuant to section 302A-(d)."
- 5. Renumber current Sections 6 through 11 to become new Sections 4-9 and delete any references to "Part I, Part II and Part III."

My name is Robert Witt and I am executive director of the Hawaii Association of Independent Schools (HAIS), which represents approximately 97 private and independent schools across our state and is an active member of the Hawaii Teacher Standards Board (HTSB).

The Association supports the intent of Senate Bill 497, Senate Draft 1 – Relating to the Hawaii Teacher Standards Board, which would establish an advisory committee that would be responsible for providing oversight of HTSB and reporting annually on the Board's operations to the Board of Education and the Legislature. In addition, HAIS would like to offer comments on the measure.

We imagine that an advisory committee for HTSB could, in addition to the main function of board oversight, serve the purpose of offering an objective perspective on the activities of the Board. The Legislative Auditor stated that the Hawaii Teacher Standards Board exceeded their authority to extend licenses beyond those granted by statute to licenses expiring in 2002 and 2003. Teachers who had their licenses extended met all the requirements imposed by the board. We should not be penalized by the action of the Standards Board.

We respectfully request that SB 497 SD 1 be amended by adding language that:

- » Amends HRS §302A-805(b) to read: "Teachers who licenses expire on June 30, 2002 or June 30, 2003 shall be granted an automatic extension of [two] seven years," and
- » Adds a new section, 302A-805(d): "Teachers whose licenses expire on or after July 1, 2009, but before July 2, 2010, shall be granted an automatic extension of one year in which to obtain a renewal of their licenses. The board, at its discretion, may grant an additional one-year extension of these licenses." Chair Takumi, Chair Rhoads and Members of the Committee:

I am most concerned with the HTSB status. I do not feel as a teacher I should be penalized for their inability to adequately or properly enact the rules as my license expires in June 2009. I have submitted the necessary paperwork as listed for their " tentative licensing renewal process" that has been undergoing a " test study". But have not heard if they got it or not. It was a rather painful and ardous process to put all the paperwork and evidence together all while also teaching full-time and not knowing if I was submitting the appropriate information to provide the necessary evidence for my license renewal. I also filed for an extension since I have yet to hear from them.

Further, the guidelines HTSB has for teacher licensing are rather outmoded and such that very qualified professionals with industry experience who want to teach are unable to get into the classroom due to this arcane licensing process and a need to take additional classes with significant cut in pay prior to even being offered the opportunity.

It would be more prudent to have a different track as these professionals cannot necessarily take a year or two off from a job to pursue teacher education classes. They would benefit by taking these classes while teaching and so would our students.

The whole HTSB needs to be reviewed and overhauled if the goal is to truly have qualified and inspirational teachers educating our next generation. The HTSB does need outside agency oversight - not oversight from the teacher union or DOE as we do have teachers at private schools who do greatly benefit from having licensed teachers. It should include the DOE and the teacher's union for valued input. Licensing is useful in that it does require/expect the

teacher to stay on top of their field, incorporating researched based and proven methods, and continue to evolve positively.

But the process and limitations of what is acceptable needs revamping and needs to be more clearly stated so that teachers know exactly what they need to do to provide evidence of continual growth.

It is counter-productive and demoralizing to penalize teacher's licenses if the HTSB is unable to fulfill their duties.
