RELATING TO PHYSICIANS

Senate Bill No. 793 establishes a Hawaii Rural Physician Loan Program and special fund for qualified students who agree to practice in rural and non-rural health professional shortage areas of the State as designated by the Department of Health. The bill also includes loan forgiveness provisions based upon years of employment as a licensed physician in health professional shortage areas of the State. The program would be financed by the Hawaii Rural Physician Loan Program special fund created by this bill. The fund would generate revenues through legislative appropriations, grants, loan payments, proceeds from operations, and interest. Senate Bill No. 793 appropriates an unspecified sum of general funds each year to carry out the program and also for deposit into the special fund.

We are opposed to this bill and cannot support the use of general funds for new programs due to the State's current fiscal situation. As a matter of general policy, this department does not support the creation of any special or revolving fund which does not meet the requirements of Sections 37-52.3 and 37-53.4 of the Hawaii Revised Statutes. Special or revolving funds should: 1) reflect a clear nexus between the benefits sought and charges made upon the users or beneficiaries of the program; 2) provide an appropriate means of financing for the program or activity; and 3) demonstrate the capacity to be financially self-sustaining. It is difficult to determine whether the fund will be self-sustaining.



My name is Jackie Berry, Executive Director of Healthy Mothers Healthy Babies Coalition of Hawaii. HMHB IS IN STRONG SUPPORT OF THE INTENT OF SB 793. This Bill would establish a Hawaii Rural Health Care Provider Loan Repayment Program to provide student loan repayments to physicians who practice in underserved communities on the neighbor islands. We would like to suggest an amendment to include Rural areas of Oahu.

One of the central components to ensuring access to health care is having qualified physicians to provide the services. As we all know, there are areas of the State of Hawaii that have very serious shortages of physicians. The data on access to prenatal care indicates that a major reason for late and inconsistent prenatal care is access to physicians, particularly on the island of Hawaii and in the rural areas of Oahu. Getting appropriate and timely prenatal care is a major indicator affecting birth outcomes.

The Hawaii Primary Care Association urges your support for this bill. We believe loan programs are a very powerful tool for recruiting and retaining health care professionals in underserved areas. It is all too apparent that Hawaii has an urgent need for such a program at this time.

We would like to request the following change to the bill in §304A- (a) (1):

“Are or will be enrolled in an education and training program for physicians with training based in Hawaii [administered by the University of Hawaii John A. Burns school of medicine that leads to eligibility for a license under chapter 453];

This preference is made as Wai‘anae Coast Comprehensive Health Center, in partnership with an accredited Medical school in Arizona, also offers medical training with a focus on developing physicians oriented toward delivering primary care in community health center-based settings. We greatly respect JABSOM’s programs but believe that these additional candidates should also be prioritized for loan repayment.

Re: Testimony for SB793 regarding health

The Hawaii State Rural Health Association would like to express our strongest support for SB793. We have conducted published research on the rural health care needs across the State and found that while all communities are unique, there are some themes that are common throughout the state. Needs that are commonly identified in our rural and underserved communities include:

1. Financial assistance (insurance coverage, medication, free services)
2. Expanding services that are available to rural communities (including tele-health services)
3. Improving access to available services (Long term care, primary care, specialty care, mental health care, substance abuse treatment, health care training and other services)
4. Decreasing drug use
5. Increasing health education and training opportunities for community members
5. Increasing the number of health care providers working in rural areas
6. Increasing cultural sensitivity of providers

The Hawaii State Rural Health Association supports legislation that will increase services to rural communities, including legislation that supports expanding the health workforce, developing assistance programs for rural areas, and expanding the facilities available to rural citizens. We expect this to be done in culturally appropriate ways with significant grass roots community involvement at all steps of the process.

Therefore the Hawaii State Rural Health Association fully supports SB793 because it will increase the number of health care providers available to provide care in rural areas and thereby increase access to healthcare services throughout the State of Hawaii, particularly the rural areas. Without interventions such as these, the growing health crisis will get worse and lives will be lost that need not be.

My name is Jim Tollefson and I am the President and CEO of The Chamber of Commerce of Hawaii ("The Chamber"). The Chamber supports Senate Bill No. 793 relating to Physicians.

The Chamber is the largest business organization in Hawaii, representing more than 1,100 businesses. Approximately 80% of our members are small businesses with less than 20 employees. As the "Voice of Business" in Hawaii, the organization works on behalf of its members, which employ more than 200,000 individuals, to improve the state's economic climate and to foster positive action on issues of common concern.

This measure provides loan repayment assistance to graduates of the John A. Burns school of medicine who practice medicine in underserved communities on the neighbor islands for a minimum of three to five years.

The quality of healthcare that Hawaii has enjoyed for years is now in jeopardy. It is on the verge of declining because healthcare providers are no longer being paid for essential services at a level sufficient to cover annually increasing costs. The health care system must be maintained and challenges must be addressed.

Therefore, The Chamber supports prescriptions of improvements of the quality of our health care system that will increase long term care capacity and access statewide. We believe providing incentives, such as to graduates of the John A. Burns school will help address the shortage of doctors, especially on the neighbor islands, as well as keep the providers in Hawaii.

In light of the above, The Chamber of Commerce of Hawaii supports SB 793. Thank you for the opportunity to testify.

I am appearing as a private citizen with extensive knowledge of medical education in Hawai‘i, to support –in concept -- Senate Bill 793.

It is important for you to understand that the John A. Burns School of Medicine does not have a mechanism to administer the financial aspects of loan repayment or collection in setting of defaults. I would respectfully suggest that another state entity with such infrastructure might be assigned to those aspects of the program.

I am aware that the medical school is pleased to disperse the funds and assist with selection of worthy candidates.

One additional suggestion is that the bill should specify physician training that occurs in Hawai‘i.

As a physician workforce researcher in Hawaii, I fully support the creation of a loan repayment program for physicians who practice in areas where there are not enough health care providers. My research team is in the process of analyzing where the greatest shortages are. The PRELIMINARY analysis of the licensed physicians working in Hawaii indicates an urgent need for more primary care providers and orthopedists on the Big Island, psychiatrists on Maui, rheumatologists, neurologists, cardiologists and nephrologists in most rural areas of the state, and a growing need for primary care providers, including geriatricians, statewide.

In addition, our focus group research indicates that the greatest barrier to work in rural areas is financial, including the high cost of living. Loan repayment is a practical and immediate method of enticing doctors to go to the shortage areas. While it alone will not solve the entire problem, as part of a plan that includes pipeline programs, increased training, regionalization of care, reliable transportation, modern information sharing and a collaborative model of patient care, will go a long way to meeting the local healthcare needs. You also should keep in mind that there is a federal grant program called State Loan Repayment Program that may provide matching funds for scholarships provided by states to support primary care providers in underserved areas. As a recipient of many federal grants, I offer my assistance in applying for such funding.
