Re: In Strong Support for Senate Bills 798 and 799, Board of Education; Student Member:

Mr. Chairman and Members of the Committee:

My name is Robert Firme, from the Hawaii State Student Council and I would like to speak in strong support on behalf of Senate Bills 798 and 799.

In the State of Hawaii, there are 285 public schools serving approximately 181,355 students. However, with a student population so big, one would expect that some form of student representation should be allocated. Yes, it is true that all 181,355 students are represented by the single BOE student member on the board, but what's more is that this elected representative, voicing the positions of the 181,355 students, does not even have the same right as the other Board members to vote on concerns delegated to the mass student populace. All these decisions concerning the students may have the verbal representation orated by the student member, but these Board decisions have been passed without the truest form of student representation of the student voice and stance, that can only come in the form of direct voting.

The BOE student member is a competent student, one that has been screened and approved by the students and monitored by the adults, such as the HSSC advisor and Board themselves, acting out most of the duties and responsibilities expected of each member, goes to every Board function, listens to the same concerns as the rest of the Board, and essentially carries out the duties as every other member. The only real differences separating the student member from the rest of the Board is his/her age and the right to vote; what issue and apprehensions could be so problematical as to deprive an active member of the board of their right to vote! The student member should be given the right to vote on Board decisions because he/she is in direct representation and connection with the students, is knowledgeable enough to understand the wills of the students, and competent enough to make intelligent decisions to protect the students' welfare.
